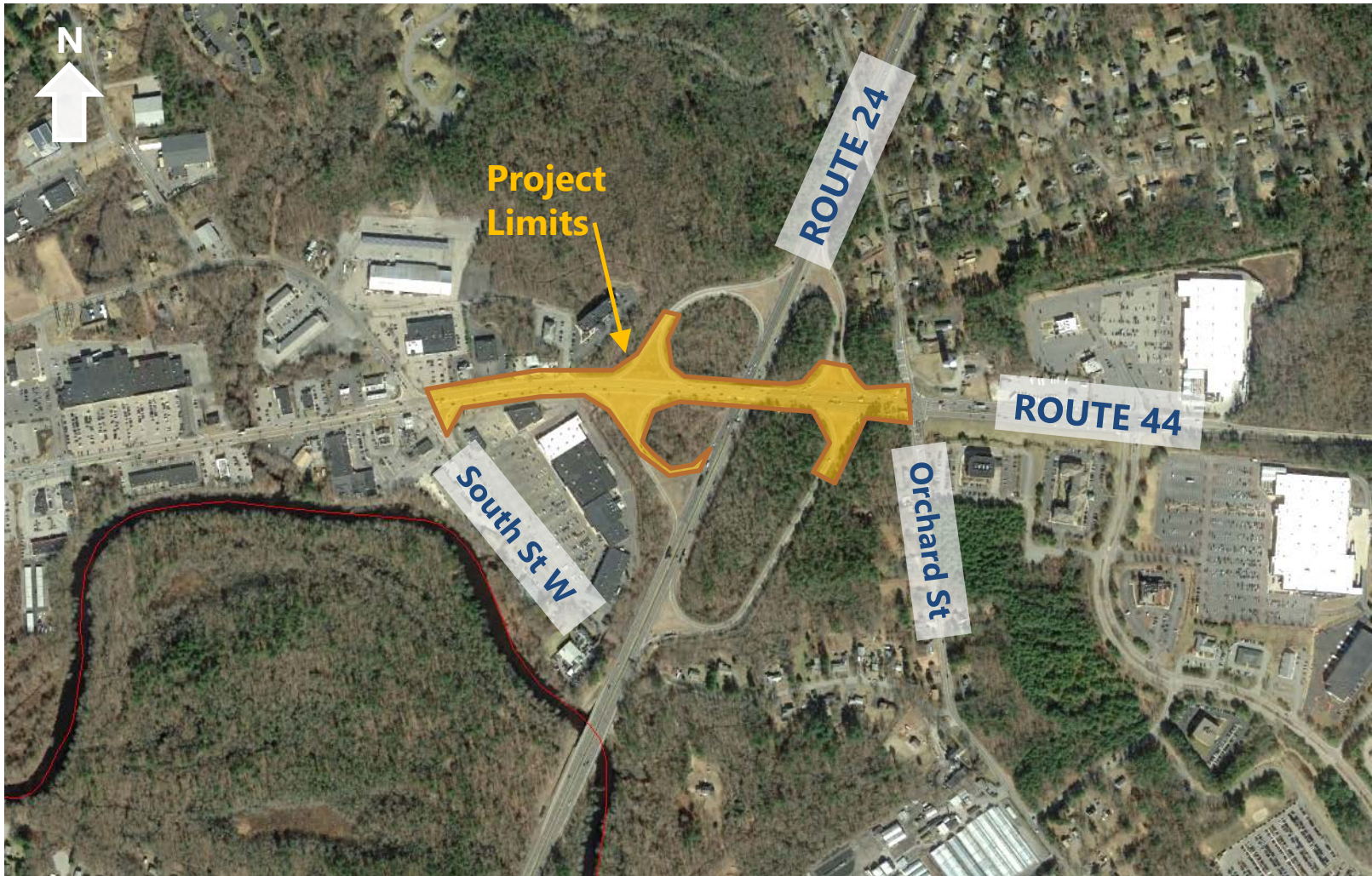

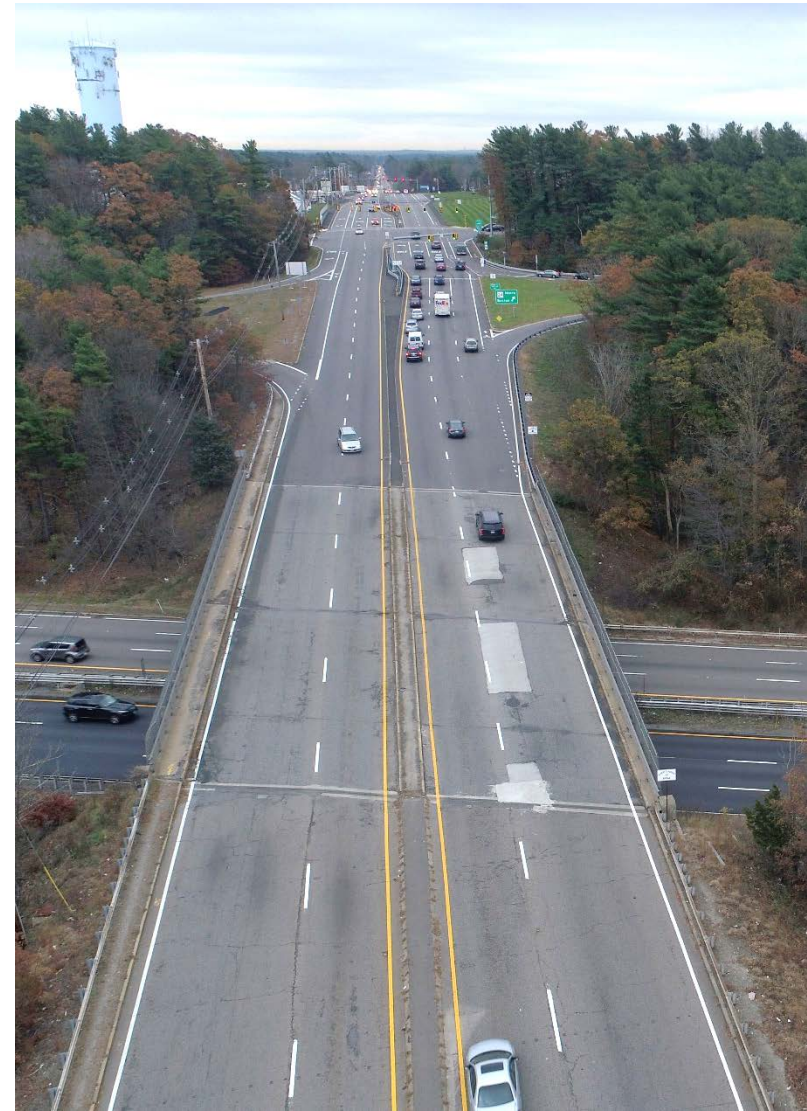

Existing Bridge

- Existing four span bridge in poor condition
- Single sidewalk on north side, no sidewalk connectivity throughout project limits
- Narrow shoulders, no bike accommodations



Existing Bridge Condition

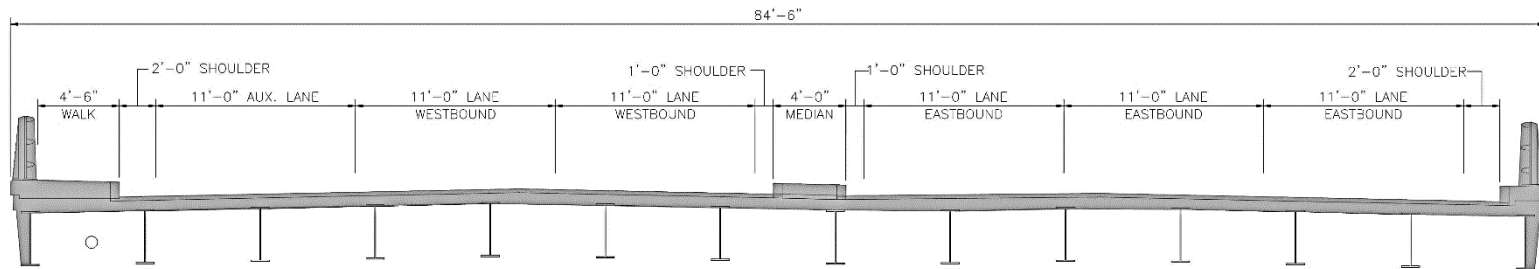


Proposed Bridge Configuration

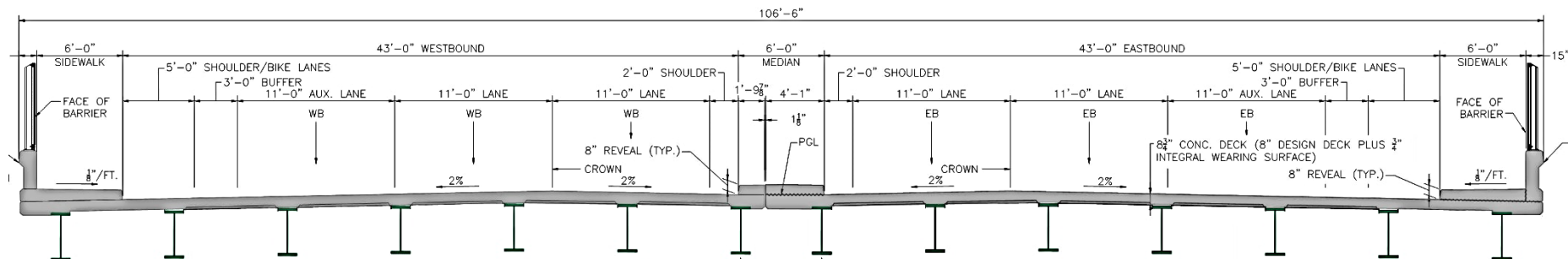


Route 44: Proposed Cross Section

- 5ft bike lanes, 3ft buffers, and 6ft sidewalks each side



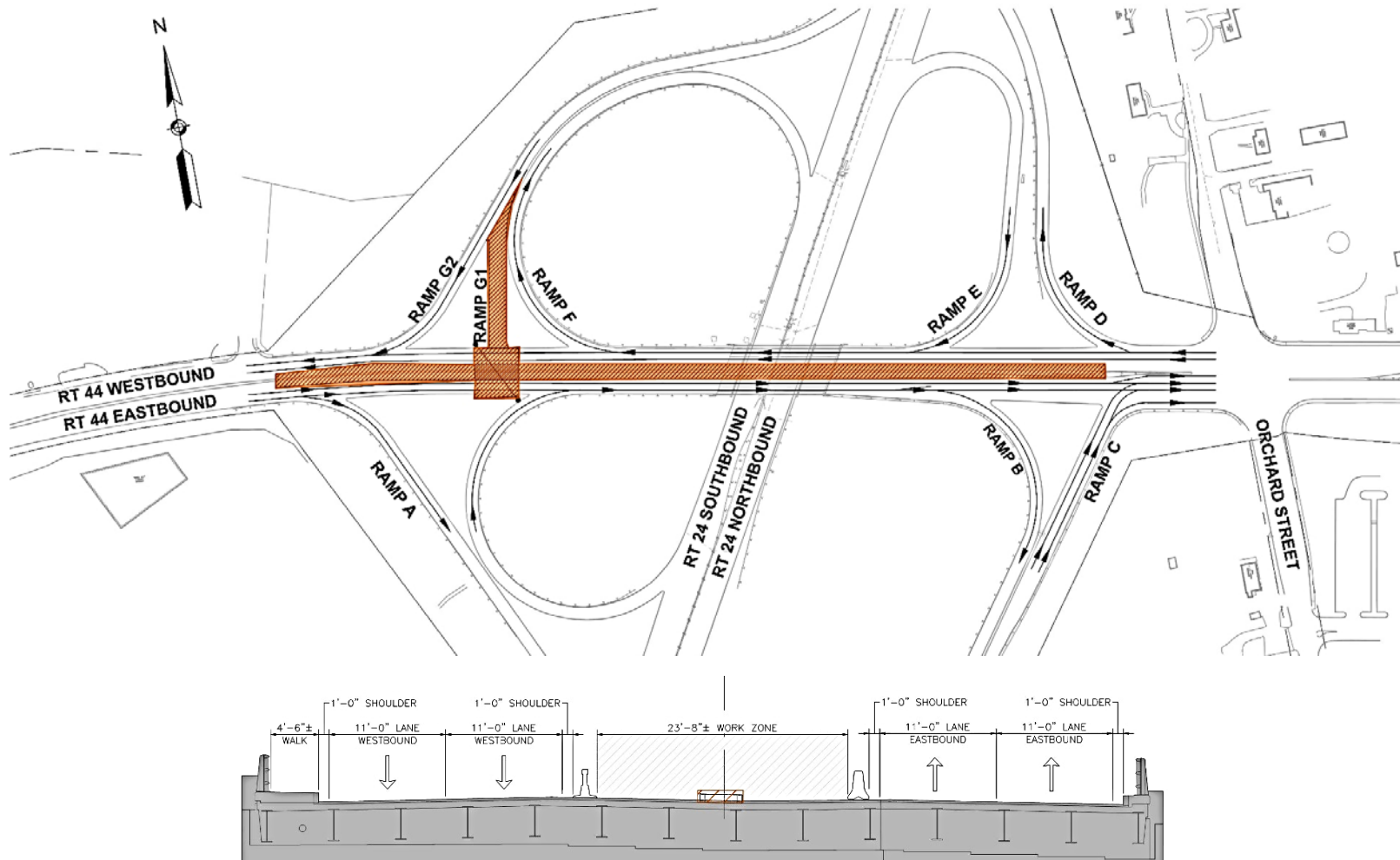

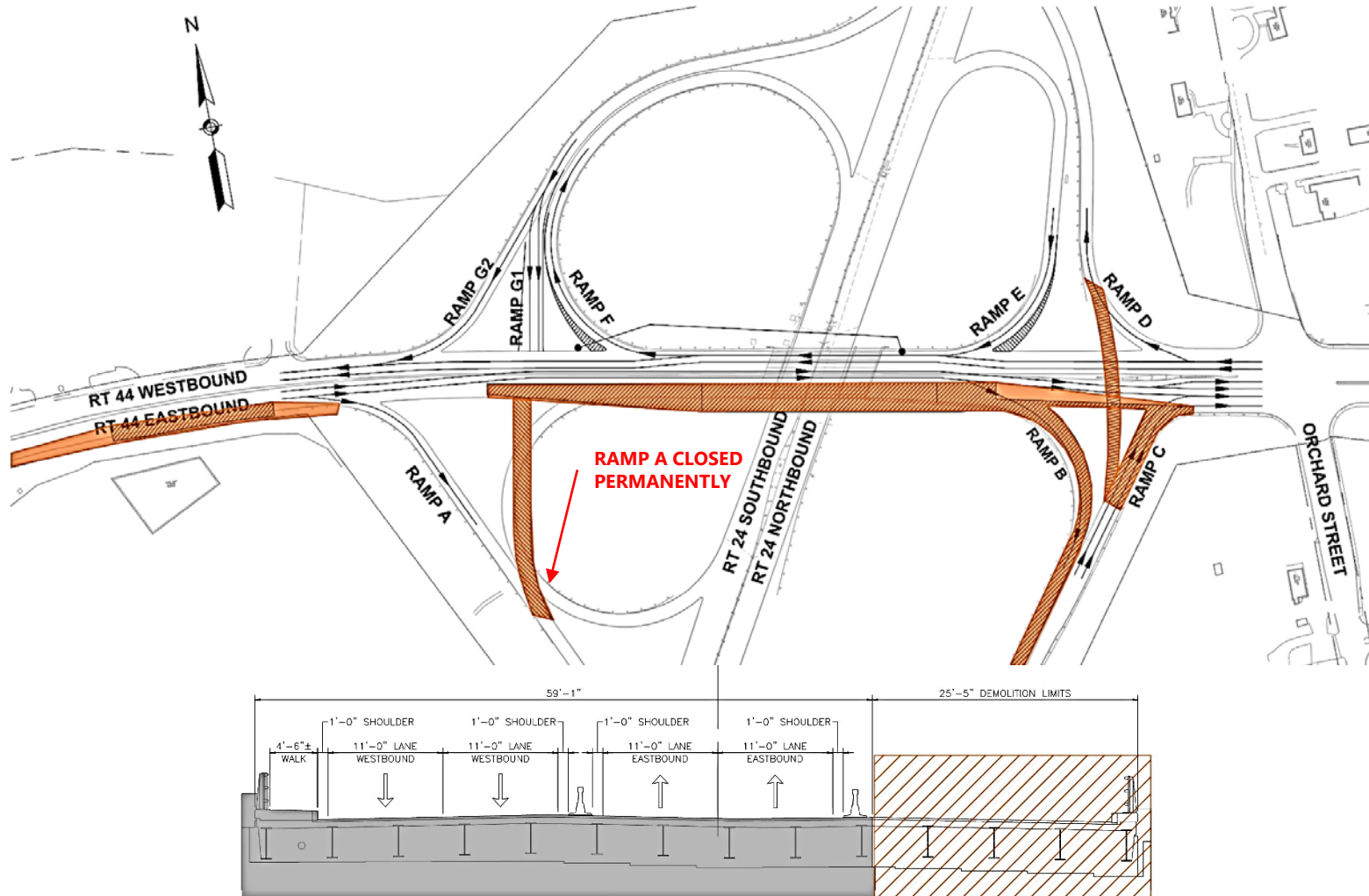
Construction Staging: Stage 1 (Sept 2018)

Rte 44 Median and Ramp Reconfiguration



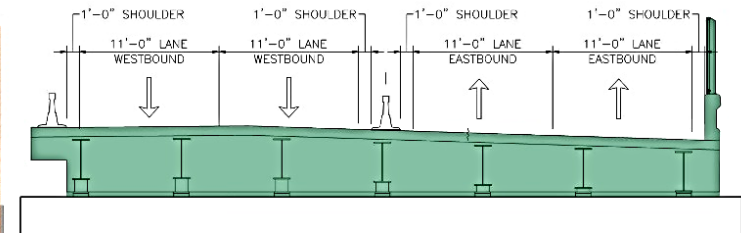
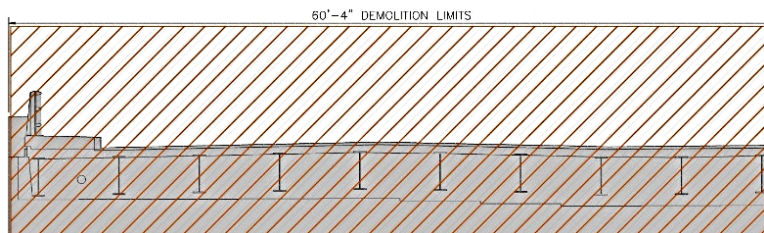
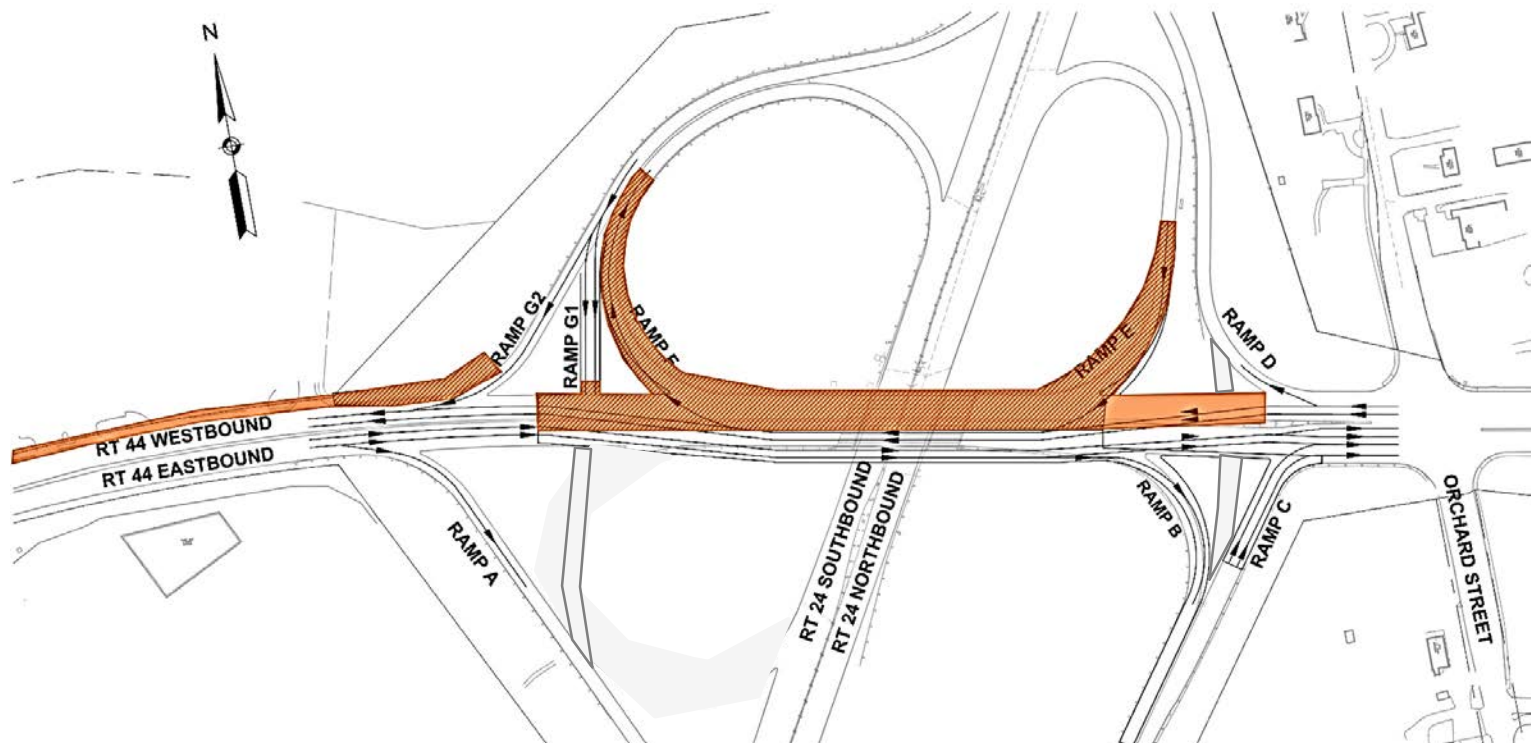
Construction Staging: Stage 2 (Fall 2018)

Shift Rte 44 traffic north, reconstruct southern half bridge



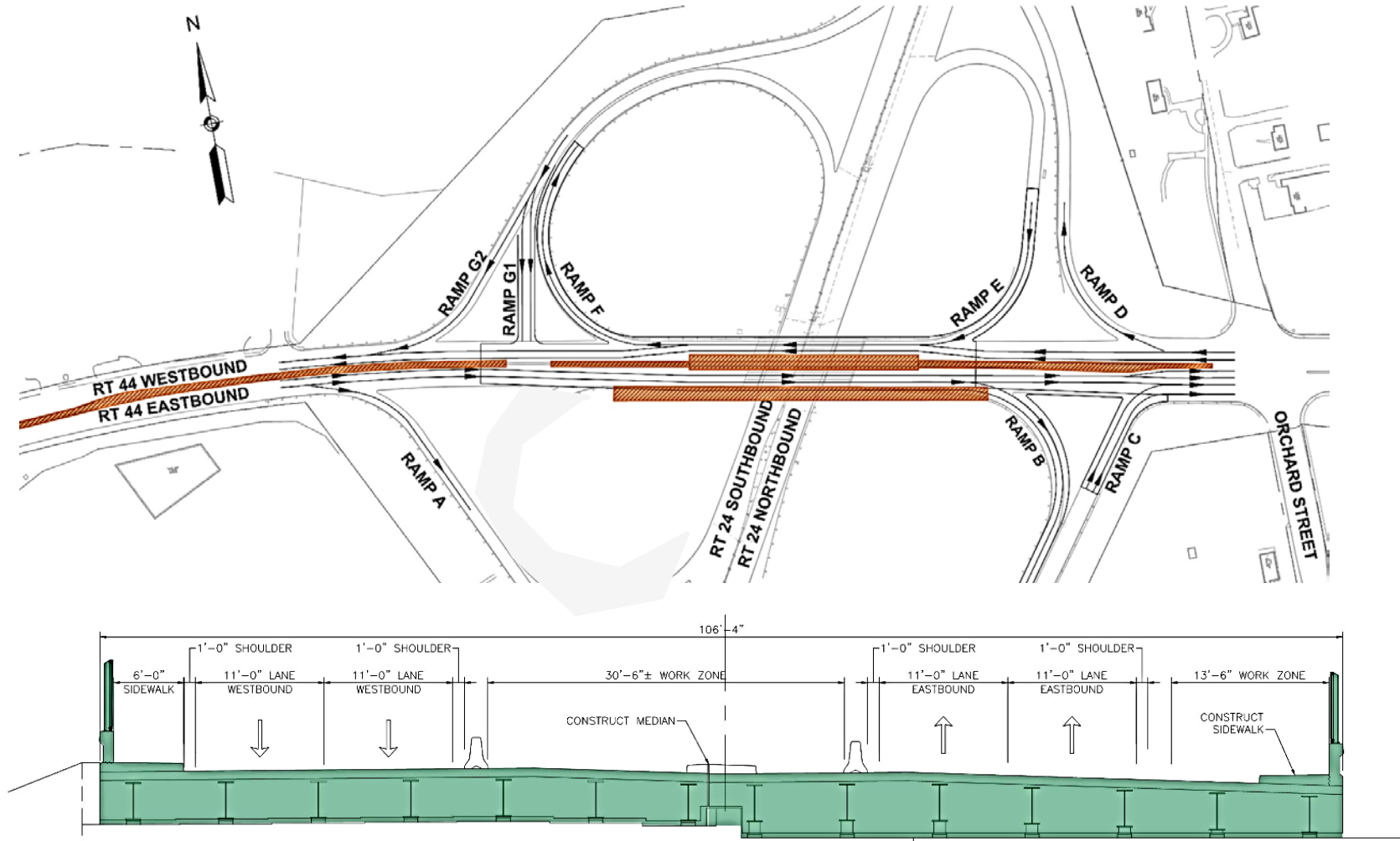
Construction Staging: Stage 3 (Summer 2019)

Shift Rte 44 traffic onto new bridge, reconstruct northern half of bridge



Construction Staging: Stage 4 (Summer 2021)

Complete median and sidewalk work



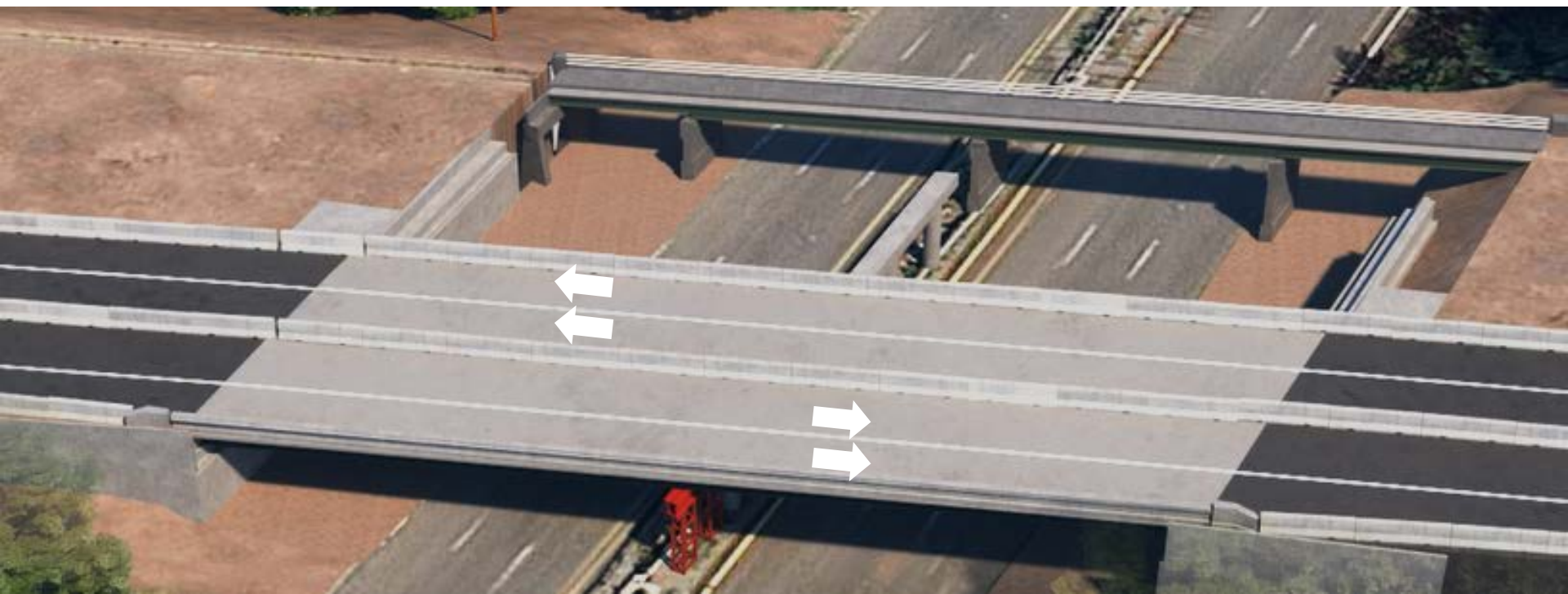
Project Schedule

- September 2018: Stage 1 (Rte 44 median and ramp reconfiguration)
- Fall 2018: Stage 2 (shift Rte 44 traffic north, reconstruct southern half of bridge)
- Summer 2019: Stage 3 (shift Rte 44 traffic onto new bridge, reconstruct northern half of bridge)
- Fall 2020: Slide southern half of bridge into final alignment
- Summer 2021: Stage 4 (complete median and sidewalk work)
- Late Summer 2021: Project Full Beneficial Use

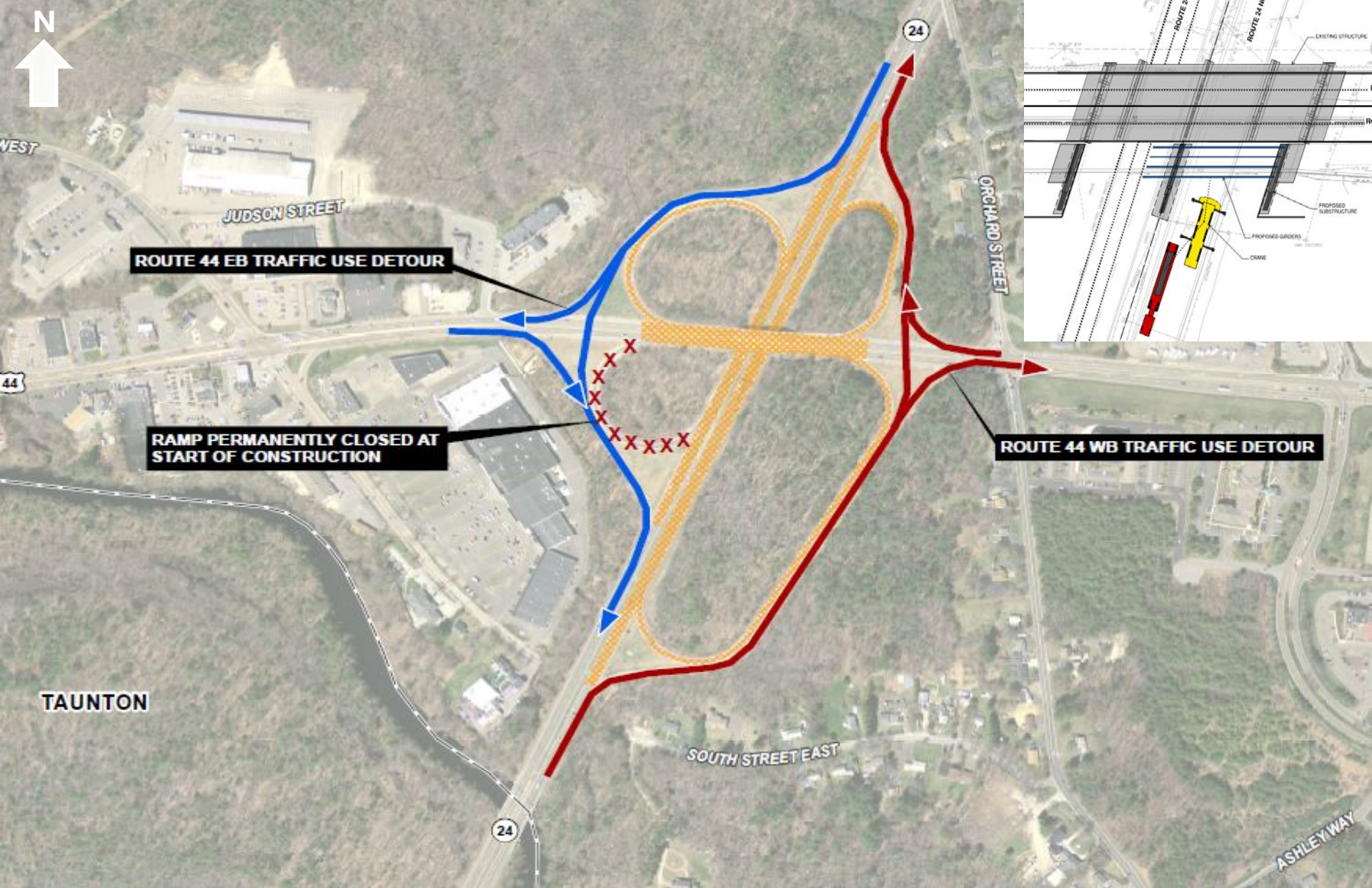
Traffic Management Approach

- Traffic and work zone safety
- Minimized mobility impacts – maintain 2 lanes each direction for both 44/24, except for temporary off peak closures
- Outreach and communication
- Real-Time Traffic Management (RTTM) System

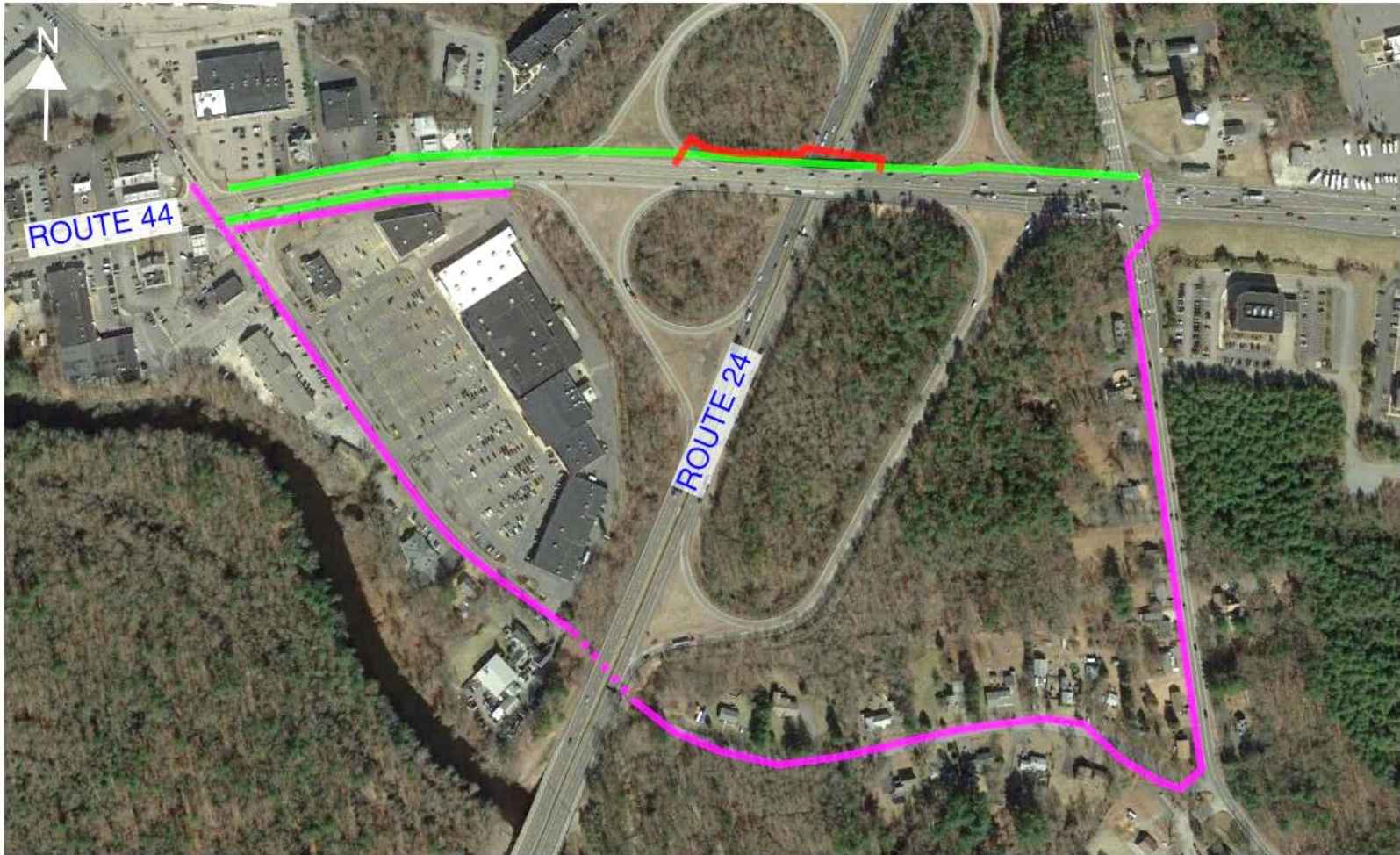
Proposed Route 24 detour (limited overnight shutdowns)

Utility Relocations

- Existing TMLP/Verizon/Comcast on pole line north side of Route 44
- Existing Columbia gas line supported on bridge (north side)
- Currently pursuing options to relocate overhead utilities down South Street West and gas line under Route 24

MassDOT's project to replace the existing Route 44 over Route 24 bridge in Raynham will begin soon. Prior to the start of major construction in October 2016, MassDOT's contractor, STS New England, will perform early action work that includes surveying, tree and brush clearing, and ramp modifications.

The primary goal of the Route 44 over Route 24 Bridge Replacement Project is to replace the existing bridge structure, which is structurally deficient and functionally obsolete. Other project goals include incorporating functionality and safety improvements into the roadway and highway interchange system between South Street West and Orchard Street on Route 44. The project also includes widening the bridge and adding new bicycle lanes, improving bicycle, pedestrian and ADA access, and increasing the vertical clearance of the bridge, and more.

At this meeting, MassDOT and the project team will present an overview, discuss traffic management, and respond to questions. The presentation will take place during the Board of Selectmen meeting.

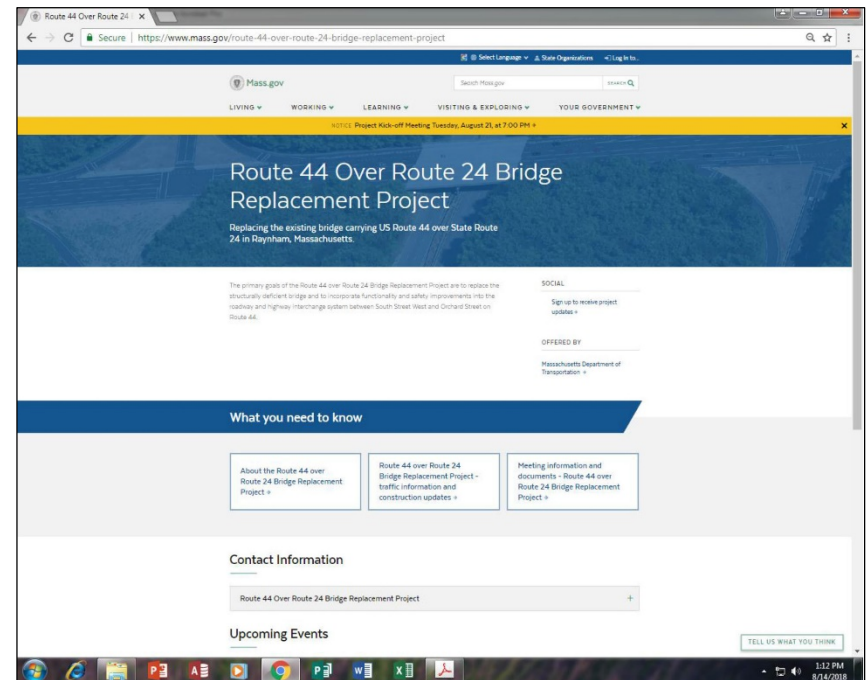
