SECTION 1 --

ITEM 1 - Labor Charges

Our rates are calendar based and by the hour.

These charges apply to services not otherwise covered in this tariff when such services are requested by the shipper.

Extra Mover \$40/Hour

Extra Truck \$45/ Hour

ITEM 2 - Storage in Transit

If the shipper requests the shipment be held in storage before delivery to the point of destination, the following charges will apply.

SECTION 3 -- RULES AND REGULATION -- RATES

RULE 4 -- Warehouse Delivery

Except as provided in Rule 4, when goods are consigned or delivered to a warehouse, the location of the warehouse will be considered the destination and must be noted on the Bill of Lading. King Movers will end when the shipment is unloaded into the warehouse. The goods will be stored in the name of the shipper, owner, or consignee, subject to a lien for transportation and other lawful charges.

RULE 6 -- Regular Hours of Service

King Movers regular hours of service are between 7 AM and 6 PM each day except for Saturdays, Sundays, and legal holidays, except as otherwise provided.

RULE 7 -- Minimum Charge

Unless otherwise specifically our minimum rate is 3 Hours plus travel time.

RULE 8 -- Payments

A. King Movers will not deliver or hand over any shipment or any part of a shipment until all rates and charges have been paid in cash, or by an approved credit card(s).

RULE 9 -- Replacement Value Protection

When Replacement Value Protection is requested in writing by the customer, King Movers Company will be liable to the maximum declared released value for replacement of the articles lost or damaged while in King Movers Company custody.

Option A--- Replacement Value Protection will be provided by King Movers Company through a Third party companies affiliated.

Option B-- No Deductible

The customer will pay for the protection 60¢ per pound, per article.

Note 1 – King Movers Company maximum liability will not exceed the release or declared value on the shipment, 100% of the actual cash value of the item(s), or the full repair cost, whichever is less.

Note 2 -- This protection does not apply to lost, damaged, destroyed, or missing papers of any kind, including accounts, bills, passports, deeds, stocks, bonds, and money. This protection does not apply to items such as photographs, newspaper clippings and heirlooms having little or not market value. This protection does not apply to loss or damage due to insects or extreme temperatures.

Limitation on Service

Service(s) may not be used for any unlawful purposes.

King Movers Company reserves the right to discontinue service(s) upon written notice, when necessitated by conditions beyond its control or when the customer is using its services in violation of the provisions of this tariff or in violation of the law.
