DECISION ON JOINT MOTION FOR EQUITABLE RELIEF

The Appellant, Jeffrey King, filed this appeal with the Civil Service Commission on January 26, 2005 pursuant to G.L. c. 31, § 2(b). The Appellant seeks relief from a decision by the Respondent, Medford Fire Department (hereafter "Department") as Appointing Authority, bypassing him for original appointment to the position of Permanent Full-Time Firefighter in the Department. This appeal had been allowed by the Commission on September 28, 2006. In that decision, the Commission found that the selection process employed by the Respondent was flawed. Because of this concern, the Commission ordered equitable relief for the Appellant and also ordered that the Commission would "maintain jurisdiction over the hiring of any firefighters by the City of Medford." Subsequently, the Commission learned that the Appellant had once again been bypassed for an offer of conditional employment by the Department, allegedly due to his imminent re-deployment for duty with the United States Army in Iraq. As a result of this allegation, the Commission convened an emergency discussion with the parties in

order to enforce its September 28, 2006 decision. The parties reached a resolution of the matter and submitted an agreement to the Commission on October 10, 2007.

The Commission accepts the agreement of the parties on this matter, which has been appended hereto, and, pursuant to the powers of relief inherent in Chapter 534 of the Acts of 1976 as amended by Chapter 310 of the Acts of 1993, orders the Human Resources Division (hereafter "HRD") to take the following action:

The HRD is to place the name of Jeffrey King at the top of the eligibility list for original appointment to the position of firefighter so that his name appears at the top of the existing certification list, or the next certification list if the current one has expired, requested by the City of Medford from HRD and from which the next original appointment to the position of firefighter in the Medford Fire Department shall be made by the City of Medford and for which Mr. King will be available following his military service.

The letter sent to the HRD by the Department, dated March 9, 2007, stating the reasons for bypassing Jeffrey King, pursuant to c. 31, § 27, is hereby rescinded. The reasons, including Mr. King's driving history, as set forth in the aforementioned letter of bypass shall not be considered by or used in any way by the Appointing Authority in the future with regard to Mr. King's candidacy for a public safety position in the City of Medford.

It is further ordered that the Commission's order of September 28, 2006 to maintain jurisdiction over the hiring of any firefighters in the City of Medford is hereby rescinded.



Now come the parties to the above captioned matter and hereby stipulate and agree as follows:

That the letter sent to John O'Leary, Chief Human Resources Officer, Executive Office for Administration and Finance, Human Resources Division, dated March 9, 2007 is hereby rescinded by the Appointing Authority;

- 2. The reasons set forth in the aforementioned letter of March 9, 2007, upon which the Appointing Authority concluded that the Appellant was not a suitable candidate for a public safety position at the Medford Fire Department, shall not be considered by or used in any way by the Appointing Authority in the future with regard to the Appellant's candidacy for a public safety position at the Medford Fire Department;
- 3. The Appointing Authority agrees to reserve one opening for the Appellant for a position as a firefighter at the Medford Fire Department;
- 4. Upon the Appellant's discharge from the United States Army, the City Appointing Authority will extend to the Appellant a written conditional offer of employment to join the Fire Department as a firefighter. The offer will be conditional on the Appellant passing a pre-employment psychological examination, medical examination, background investigation, to include driving history¹, CORI check, employment history, character references and a successful interview with the Mayor;
- 5. In order to put into effect the intent and purpose of this Agreement, the parties agree and assent to the Civil Service Commission ordering the Human Resource Division to place the Appellant <u>first</u> on the Certification list pursuant to Chapter 534 of the Acts of 1976, as amended by Chapter 310 of the Acts of 1993.
