Environmental Protection (“MassDEP” or “the Department”), has designated me the Final Decision-Maker in this administrative appeal.<sup>1</sup>

I adopt the Recommended Final Decision (“RFD”) of the Presiding Officer in these four (4) consolidated appeals brought by King’s Grant Water Company, Inc. (“the Petitioner”) challenging four different civil administrative penalty assessments that the Southeast Regional Office of the Massachusetts Department of Environmental Protection (“MassDEP” or “the Department”) assessed against the Petitioner as discussed in the RFD. In adopting the Presiding Officer’s RFD, I affirm all four civil administrative penalty assessments.

The parties to this proceeding are notified of their right to file a motion for reconsideration of this Final Decision, pursuant to 310 CMR 1.01(14)(d). The motion must be filed with the Case Administrator and served on all parties within seven business days of the postmark date of this decision. A person who has the right to seek judicial review may appeal this Final Decision to the Superior Court pursuant to M.G.L. c. 30A, §14(1). The complaint must be filed in the Court within thirty days of receipt of this decision.
