## DECISION

66 MAIN ST. LIQUORS INC. D/B/A MYETTE'S COUNTRY LIQUORS 66 MAIN STREET

66 Main St. Liquors Inc. d/b/a Myette's Country Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138 § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, September 13, 2022, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Cutter's Report.

The following documents are in evidence:

- 1. Investigator Cutter's Minimum Age Compliance Check Field Report dated 6/2/2022;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved, 4/25/2022;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

## FINDINGS OF FACT

- 1. On Thursday, June 2, 2022, at approximately 6:40 p.m., Investigators Kenny and Cutter ("Investigators"), inspected the business operation of 66 Main St. Liquors Inc. d/b/a Myette's Country Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, a 6-pack of Coors Light beer, for seven dollars (\$7.00). The underage operative was not asked for identification.
- 3. Mr. Nil Patel, owner of the licensed premises, appeared at the Commission hearing and testified that 66 Main Street Liquors, Inc. had only taken over the business the day before the compliance check. He testified he has reviewed the store's policies and procedures with his employee and said employee has completed TIPS training.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
