## DECISION

KINGSTON LIQUORS, INC. D/B/A KINGSTON LIQUORS 179 SUMMER STREET, KINGSTON, MA 02364

Kingston Liquors, Inc. d/b/a Kingston Liquors ("Licensee" or "Kingston Liquors") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, June 25, 2024, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Terasconi & Kenny's Compliance Check Field Report.

- 2. ABCC Form 43, Change of Location Approval, 5/11/1992;
- 3. ABCC Decision, 10/12/2022;

#### FINDINGS OF FACT

- 1. On Tuesday, March 12, 2024, Investigators Terasconi and Kenny ("Investigators") conducted a compliance check at Kingston Liquors, Inc. d/b/a Kingston Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Bud Light beer for eight dollars and twenty-nine cents (\$8.29). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 1969 with one prior violation.

### **CONCLUSION**

Based on the evidence, the Commission finds a Kingston Liquors Inc. d/b/a Kingston Liquors violated 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As a result, the Commission suspends the license for a period of one (1) day which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission regulations are found by this Commission.
