CORI POLICY

CLARB report

Mark Zarillo discussed an "In the know" zoom meeting presented by CLARB staff. CLARB was looking to connect with the board to have accurate and updated information for each jurisdiction. Mark will provide board staff with contact information to present this information to CLARB.

Reinstatement Application

The board discussed specific items they want added to the reinstatement application. This should include:

- Minimum of three projects. These projects should include construction drawings (if applicable) and whether or not their stamp was applied,
- Reference letters must be written and signed by the client on their letterhead. Digital signatures will not be accepted.
- Brief history of each year of lapsed license. Provide a detailed summary of work that was performed as well as any projects he/she was part of. Define his/her role in these projects and identify whether or not the stamp was used.
- Licenses can be renewed late the first year after expiration date
- If license lapsed for more than 5 years, all of above needs to be provided as well as a meeting with the board

On the application the following changes should be made:

- Change issue date to original issue date
- Attestation stamp page should include "stamp, title, or registration number used on an MA projects"
- Separate out the attestation piece so its clear if they did nor did not use the stamp
- Clarify that until reinstated, individuals cannot use title, stamp, or license number for any purpose

Board staff will work with board counsel to make these changes.

Voted: To have Pamela Shadley be the final review of the updated reinstatement application. If it is substantially correct, she can approve. If there are any issues it will be brought back to the board at the September board meeting.
