### **Executive Summary**

In the fall of 2018, The Town of Lanesborough signed a Community Compact agreement with the Baker-Polito administration. The Town selected the Engagement and Transparency best practice to better provide public information to constituents. The Town of Lanesborough is located near the western border of Massachusetts. First named Richfield, then New Framingham, the name of the Town was finally changed to Lanesborough when it was incorporated in 1765.<sup>2</sup> Today, the Town is known for its natural attractions, such as Mount Greylock State Reservation,

Balance Rock State Park, and others. The Town has a population of 3,004 and a median household income of \$76,016.<sup>3</sup>

## **Challenges**

Through this Community Compact initiative, the Town sought to be more open and transparent by upgrading the municipal website to streamline public information dissemination, including municipal financials, and address the growing demand and expectation of easier access to information access.

Given limited resources, the Town needed to address constrained business hours, which directly impact public information accessibility. In addition, that town had keep ADA (Americans with Disabilities Act) compliance in mind when considering the implementation of online resources.

The Town was also challenged in developing a sustainable strategy for the deployment of a new website, in that financial resources and staffing for content management and dissemination are limited.

### **Solutions**

Leveraging Community Compact best practice grant funding, the Town hired vendors CivicPlus and ClearGov to deploy and enhanced website and municipal financials transparency platform. With the newly upgraded municipal website, the Town was able to improve navigation, the ability to keep content current and ensure accessibility for all website visitors.




Redesigned Town of Lanesborough Website<sup>4</sup>


