# **DECISION**

EL CESAR'S RESTAURANT INC. DBA EL CESAR'S RESTAURANT

380 COMMON STREET LAWRENCE, MA 01840 LICENSE#: 059400201

El Cesar's Restaurant Inc. dba El Cesar's Restaurant (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 28, 2015, regarding an alleged violation of 204 CMR 2.05 (2) - Permitting an Illegality on the Licensed Premises, to wit: 527 CMR 10.13 (2) (e) - Failure to complete the Fire & Building Safety Checklist as prescribed by the Marshall, on each day of operation prior to opening the facility to patrons. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Keefe's Report.

The following documents are in evidence:

- 1. Investigator Keefe's Investigative Report dated May 2, 2015; and
- Licensee's Stipulation of Facts.
- A. Crowd Manager Training Certificate Ronald Castro; and
- B. Crowd Manager Training Certificate for Cesar Vargas.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's file.

### **FACTS**

- 1. On Saturday, May 2, 2015, at approximately 11:40 p.m., Investigators Bailey, Kujawski, and Keefe ("Investigators") conducted an investigation of the business operation of El Cesar's Restaurant Inc. dba El Cesar's Restaurant to determine the manner in which its business was being conducted.
- 2. Investigators entered the licensed premises and identified themselves to the owner, Ceasar Vargas.
- 3. Investigators asked Mr. Vargas if he had completed the Fire and Building Safety Checklist.
- 4. Mr. Vargas stated that he had not filled out the checklist, and he had not done so in quite some time.

- Investigators informed Mr. Vargas of the violation and that a report would be filed with the Chief Investigator for further action.
- 6. Mr. Vargas and his daughter, Heidi Vargas, represented to the Commission that in 2015 the Licensee increased its capacity to 207 persons, and that prior to then, the Licensee was not required to complete the Fire & Building Safety Checklist.

### CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) - Permitting an Illegality on the Licensed Premises, to wit: 527 CMR 10.13 (2) (e) - Failure to complete the Fire & Building Safety Checklist as prescribed by the Marshall, on each day of operation prior to opening the facility to patrons. Therefore, the Commission suspends the license for two (2) days of which two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
