

Statement of Intent	I intend to comply with and advance the policy established by this Act.
Statement of Interest	As a constitutional scholar and teacher, it seems clear to me that, while the rulings of the U.S. Supreme Court interpreting the U.S. Constitution are entitled to respect, the court is not infallible. The Citizens United decision reflects a fundamental misunderstanding of the First Amendment's freedom of speech, a misunderstanding, given the nature of constitutional law, that can only be corrected through an amendment. The effort must ensure that the rights of people of actual human beings are prioritized. For it is individuals the framers intended to protect under the First Amendment, by ensuring that the state and federal governments could not undermine their ability either to speak or to be heard. At the same time, any amendment effort must be sensitive to the gravity of such an undertaking. We should take steps to make sure that any addition to a constitution which has been amended just 27 times in 200 plus years is as clear in its scope and reach as we can make it, so that the amendment itself causes as little future misunderstanding as it is possible for us to prevent today. In addition to teaching constitutional law for the better part of the past two decades, I have written or co-written numerous books and articles about state and federal constitutions. This work includes a constitutional law casebook for law students; I also serve as the series editor of the Oxford Commentaries on the State Constitutions of the United States.
