




## **Project Scope**

#### Purpose & Need

- The goal of the LMRC section in Lawrence is to provide a safe and inviting multi-use transportation project that spurs economic development, provides strong pedestrian and bicycle connections, and creates newly developed open space encouraging recreational and educational opportunities.
- Construct a 1.5 Mile long shared-use path along the abandoned Boston-Maine Railroad Right-Of-Way between Lawrence, Massachusetts and Manchester, New Hampshire.
- Utilize street space elements including benches, shade trees and pedestrian plaza spaces to enhance and promote multimodal usage.





## **Scope of Services**

- The LMRC project will rehabilitate existing bridges over the Merrimack River and South Canal and replacing two existing bridges: Manchester Street and one under Lowell Street.
- Completes the connection between the cities of Lawrence and Methuen.

### **Construction Management Approach**

- Traffic maintenance shall be done only during working hours. Shortterm temporary lane closures will be allowed with prior written permission of the Engineer.
- Work will be done using one 8hour shift per day, 5 days a week, between the hours of 7:00 am and 3:30 pm. Night work is not anticipated.



• Construction will take approximately three (3) years to complete (1063 calendar days).

#### PURPOSE:

The purpose of this Staff Summary is to request that the Board of Directors authorize and approve the Secretary/CEO, or her designee, to execute MassDOT Contract No. 128034 titled Lawrence – Manchester Rail Corridor (LMRC) Rail Trail with J F WHITE CONTRACTING CO, for the amount of \$39,407,000.00 and for a total duration not to exceed 1063 calendar days from Notice to Proceed (NTP).

#### TOTAL PROGRAM BUDGET:

The LMRC Contract has a total program budget of \$46,509,805.00 which includes the following:

#### DISCUSSION:

This regional trail project will connect areas of cultural, economic, social, and natural significance along the multi community corridor and provide a non-motorized transportation and recreational alternative for people of all ages and abilities. The project meets Beyond Mobility priorities for Safety, Supporting Clean Transportation and Destination Connectivity.

The Lawrence - Manchester Rail Corridor (LMRC) Rail Trail is an abandoned Boston-Maine Railroad right-of-way between Lawrence, Massachusetts and Manchester, New Hampshire. The overall project (as proposed) at 7,900 feet or 1.5 miles in length would utilize the right-of-way to create multi-modal connectivity between the two cities through the construction of a shared-use path. Installation of street space elements along the shared-use path are proposed to enhance and promote multi-modal usage, such as benches, shade trees and pedestrian plaza space.

Within the City of Lawrence, the LMRC generally parallels State Route 28 from north to south. The LMRC will rehabilitate the existing bridges over the Merrimack River and the South Canal at the south end of the project to provide for the Rail Trail traversing the existing structures. The project proposes replacing two bridges toward the north end of the project, one over Manchester Street and one under Lowell Street. The goal of the LMRC section in Lawrence is to provide a safe and inviting multi-use transportation project that spurs economic development, provides strong pedestrian and bicycle connections, and creates newly developed open space encouraging recreational and educational opportunities.

Other related work includes clearing, grading, pavement and concrete sidewalk, access ramps, installation of signage, pavement markings, plantings, lighting and bike path amenities.

#### PROCUREMENT:

On September 7, 2024, the Highway Division advertised this contract for bids. On December 3, 2024, two (2) bids were opened for this contract. J F WHITE CONTRACTING CO was the lowest responsive and eligible bidder with a bid price of \$39,407,000.00

The bids were reviewed by engineers in the Project Management, Construction, and Construction Contracts Sections. The Highway Division has accepted the bid submitted by J F WHITE CONTRACTING CO which at \$39,407,000.00 is 53.6% above the office estimate of \$25,655,740.00.

The following is the list of the bidders with the corresponding bid prices:

Disadvantaged Business Enterprise ("DBE") participation is required. The DBE requirement for this Project is 15% of the Contract. MassDOT's Office for Diversity and Civil Rights has reviewed the DBE information included in the Proposal of the chosen bidder and recommends the award of the DB Contract to this team.

#### FINANCIAL IMPACT/BUDGET SOURCE:

This action is funded through the Federal Aid – Congestion Mitigation/Air Quality Improvement Program (CMAQ). The total cost for this construction contract is funded with 20% State Funds and 80% Federal Funds. All the funding necessary for the construction of this project is provided in the FY25-FY29 (C) MassDOT Capital Investment Plan. There will be no potential projects placed at risk with the approval of this request by the MassDOT Board of Directors.

#### FUTURE ANTICIPATED AUTHORIZATIONS:

There are no future anticipated authorizations.

#### **RECOMMENDATIONS:**

It is recommended that the Board of Directors authorize the Secretary, or her designee, to award and execute MassDOT Contract No. 128034 entitled Lawrence – Manchester Rail Corridor (LMRC) Rail Trail, with J F WHITE CONTRACTING CO, in a form approved by the General Counsel, in the amount of \$39,407,000.00.



The notice must take the form of an affidavit sworn to by the owners of the firm before a person who is authorized by state law to administer oaths or of an un-sworn declaration executed under penalty of perjury of the laws of the United States. You must provide the written notification within 30 days of the occurrence of the change. If you fail to make timely notification of such a change, you will be deemed to have failed to cooperate under 49 CFR 26.109(c).

To renew your firm's DBE certification and if it continues to meet the applicable criteria, on or before your firm's certification anniversary date of **December 27, 2024**, and each year thereafter, please send the MassUCP the following documents:

- (1) No Change Affidavit (will be sent with reminder letter)
- (2) A <u>signed</u> copy of your company's and all of its affiliates', U.S. Tax Returns including all schedules and attachments for the year(s) indicated.
- (3) A signed copy of your personal tax returns for year(s) indicated.
- (4) If a sole proprietor, <u>a signed</u> copy of your Schedule C. for year(s) indicated.
- (5) A <u>statement</u> of the <u>number only</u> of full- and part-time employees (including owner) for each year indicated.

MassUCP reserves the right to monitor, perform random spot checks, re-evaluate the firm or revoke the firm's certification if it no longer meets the certification criteria.
