MEMORANDUM AND ORDER ON LICENSEE'S REQUEST FOR RECONSIDERATION

SPICKET RIVER BREWING LLC 56 ISLAND STREET LAWRENCE, MA 01840 LICENSE#: 05062-BP-0594

Spicket River Brewing LLC (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "ABCC" or "Commission") held a hearing on November 17, 2020 regarding alleged violations of:

- 1) 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Massachusetts Executive COVID-19 Order No. 37 (June 6, 2020) Violation of sector specific workplace safety standards for restaurants to address COVID-19;
- 2) 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Massachusetts Executive COVID-19 Order No. 40 (June 19, 2020) Violation of sector specific workplace safety standards for restaurants to address COVID-19;
- 3) 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Violation of Mass. Exec. COVID-19 Order No. 52 (September 29, 2020);
- 4) 204 CMR 2.05 (2) Permitting an Illegality on the Licensed Premises, to wit: Ch. 138 § 34C
 Possession of an alcoholic beverage by a person under twenty-one (21) years of age (1 Count).
- 5) 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: 527 CMR 1.05 § 10.5.2.1 Overcrowding or admittance of any person beyond the established posted occupant load shall be prohibited.

By decision dated December 31, 2020 the Commission found the Licensee in violation and indefinitely suspended the License effective forthwith until further written order from this Commission.

The Commission stated that it would consider issuing a further order upon written request of the Licensee showing good cause to reconsider this indefinite suspension. Good cause for the Commission would include, but not be limited to, the Licensee's receiving approval from the Massachusetts Department of Labor Standards ("DLS") as to a reopening plan.

On January 7, 2021, the Commission received the letter of approval from Massachusetts Department of Labor Standards ("DLS"). On January 8, 2021, the Licensee submitted a written request to reconsider the indefinite suspension.



Good morning, Ms. Hathaway:

I am counsel to Spicket River Brewing, LLC, owner of the Spicket River Brewery located at 56 Island Street in Lawrence. On December 31, 2020, the ABCC ordered the indefinite suspension of the Brewery's License # 05062-BP-0594 for a number of violations including violations of COVID-19 related Executive Orders. See attached Order. Immediately following the incident that led to the indefinite suspension, my clients began working with the City of Lawrence to implement procedures for compliance with COVID-19 related guidelines. Since receipt of the ABCC Order, my clients have worked with the Department of Labor Standards to develop and implement a COVID Control Plan. Earlier this morning I received notice from DLS COVID Response Team Investigator Evan Marshall that DLS had completed its investigation and approved the Brewery's COVID Control Plan. My clients have worked diligently to rectify the violations cited in the ABCC Order and to ensure that such violations will never happen again. If reinstated, the Brewery will be a model Licensee.

I ask that the ABCC consider the above as good cause to lift the indefinite suspension and reinstate my client's License to operate the Spicket River Brewery. Please advise. Thank you.
