#### NOTICE OF PUBLIC HEARINGS

Relating to the Interbasin Transfer Application For the Lynnfield Center Water District's Proposal for a Water Supply Connection with the Massachusetts Water Resource Authority

The Massachusetts Water Resources Commission hereby gives notice pursuant to MGL c. 21 §§ 8B - 8D, and 313 CMR 4.00, Interbasin Transfer Act (ITA) and Regulations, that it will conduct two virtual public hearings, one each for the donor and receiving basins, to receive public comment on the proposed permanent interbasin transfer.

The Lynnfield Center Water District (LCWD) is proposing to connect to the Massachusetts Water Resource Authority (MWRA) in order to purchase up to 0.83 million gallons per day (MGD) of water to supplement its existing water supply sources. LCWD has its sources and service area in the Ipswich River and North Coastal Basins. The MWRA's sources are located in the Chicopee River and Nashua River Basins.

The Water Resources Commission is required to consider the impact of the transfer on such issues as fisheries, recreation and the aquatic ecosystem of the donor basin. To this end, the Commission has scheduled two (2) public hearings to receive comments on this proposed interbasin transfer of water:

- 1. Donor basin: January 14, 2025 at 11:00 AM. This meeting will be held online via Zoom. Please see instructions for joining at the end of this notice.
- 2. Receiving basin: January 15, 2025 at 1:00 PM. This meeting will be held online via Zoom. Please see instructions for joining at the end of this notice.

Interested parties are welcome to participate in either of the public hearings. Copies of the application, which includes both the Single Environmental Impact Report and a supplemental memo provided to the MA Environmental Policy Act (MEPA) Office by the LCWD, can be requested by contacting <u>malenfantae@cdmsmith.com</u>, the consultant for LCWD. Persons desiring to present testimony at the hearing are encouraged to provide a written summary at or before the hearings. Comments will be accepted until 5:00 PM, January 22, 2025.

It is expected that a draft staff recommendation to approve or deny the application will be presented to the Water Resources Commission at its February 13, 2025 meeting. Copies of the draft staff recommendation can be obtained by emailing <u>Vanessa.Curran@mass.gov</u>.

Following that meeting the Commission has scheduled another public hearing to receive comments on the draft recommendation which will be held online via Zoom on February 26, 2025 at 1:00 PM. Please see instructions for joining at the end of this notice.
