DECISION

THE AVOCADO CAFÉ INC. D/B/A AVOCADO CAFÉ 5 RAILROAD STREET LEE, MA 01238

The Avocado Café Inc. d/b/a Avocado Café ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, July 23, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Guarino & Fleming's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Guarino & Fleming's Minimum Purchase Age Compliance Check Field Report, 4/1/2024;
- 2. ABCC Licensing Authority Certification, New License Approved 3/01/2022;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Monday, April 1, 2024, at approximately 6:51 p.m., Investigators Fleming and Guarino ("Investigators"), conducted a compliance check at The Avocado Café Inc. d/b/a Avocado Café.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 16-ounce draft of Oktoberfest lager for nine dollars and three cents (\$9.03). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2022 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
