DECISION

LEICESTER PACKAGE STORE INC. 869 MAIN STREET LEICESTER, MA 01524 LICENSE#: 000015-PK-0600

Leicester Package Store Inc. ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, July 25, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Velez & Binienda's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Velez & Binienda's Minimum Purchase Age Compliance Check Field Report, 4/12/2023;
- 2. ABCC Form 43, Transfer of License Approval, 12/19/1991;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- 1. On Wednesday, April 12, 2023, at approximately 5:20 p.m., Investigators Binienda and Velez ("Investigators") conducted a compliance check at Leicester Package Store Inc.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24-ounce can of Twisted Tea malt beverage, for two dollars and ninety-nine cents (\$2.99). The underage operative was not asked for identification.
- 3. Ronald Canane, Licensee and Manager, appeared at the Commission hearing along with his employee who made the sale to the underage operative, and his son, Jeffrey Canane. The Commission was informed Mr. Canane has held a license at this location since 1958, converting to a corporation in 1991.

4. The Licensee has held a license under M.G.L. c. 138, § 15 since 1991 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
