

FINAL DECISION

I have reviewed the attached Administrative Consent Order with Penalty and Notice of Noncompliance signed on January 27, 2020 by Mark Sustana, Vice President of Lennar Hingham Holdings, LLC, and on January 29, 2020 by Gerard M. R. Martin for Millie Garcia-Serrano, Regional Director for the Department (Enf. Doc. 00008406).

The Department issues this Final Decision incorporating the Administrative Consent Order with Penalty. The petitioner is ordered to pay a civil administrative penalty of seventy five thousand dollars (\$75,000) within thirty days of the date of this Final Decision in accordance with paragraphs 14 and 25 of the Administrative Consent Order with Penalty. Under the terms of 310 CMR 1.01(8)(c), this proceeding is dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as any appeal to court.
