DECISION

A A & M, INC. D/B/A TRATTORIA IL VESUVIO 242 PITTSFIELD-LENOX RD LENOX, MA 01240 LICENSE#: 0602-00056

VIOLATION DATE: 07/20/2017 HEARING DATE: 10/31/2017

A A & M, Inc. d/b/a Trattoria II Vesuvio (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission" or "ABCC") held a hearing on Tuesday, October 31, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Thursday, July 20, 2017, at approximately 5:45 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business A A & M, Inc. d/b/a Trattoria II Vesuvio.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a bottle of Bud Light beer for four dollars (\$4.00). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 20 years with no prior violations, the Commission issues a **WARNING**.
