DECISION

**ANTIMONY BREWING LLC D/B/A ANTIMONY BREWING
55 PITTSFIELD ROAD, UNIT 2
LENOX, MA 01240

Antimony Brewing LLC d/b/a Antimony Brewing (“Licensee”) holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (“ABCC” or “Commission”) held a remote hearing via Microsoft Teams on Tuesday, July 23, 2024, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Guarino & Fleming’s Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Fleming & Guarino’s Compliance Check Field Report, 3/25/2024;
2. ABCC Licensing Authority Certification, New License Approved 12/20/2022;
3. Licensee’s Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

1. On Monday, March 25, 2024, at approximately 6:26 p.m., Investigators Fleming and Guarino (“Investigators”), conducted a compliance check at Antimony Brewing LLC d/b/a Antimony Brewing.
2. An underage operative working under the supervision of Investigators purchased an alcoholic beverage, one 10-ounce of IPA Double Displacement beer, for six dollars and fifty cents (\$6.50). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2022 with no previous violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
