INTERNATIONAL BEVERAGE CENTER, INC. DBA NEJAIMIE'S WINE & LIQUOR 444 PITTSFIELD ROAD LENOX, MA 01240

International Beverage Center, Inc. dba Nejaimie's Wine & Liquor (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, November 13, 2012, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age, which occurred on May 16, 2012 according to Investigator Keefe's Report.

FACTS

- 1. On Wednesday, May 16, 2012, at approximately 5:57 p.m., Investigators Kujawski and Keefe conducted an investigation of the business operation of International Beverage Center, Inc. dba Nejaimie's Wine & Liquor.
- 2. An underage operative working with investigators purchased an alcoholic beverage, a twelve ounce (12 oz.) can of Budweiser Light beer, for one dollar and twenty-five cents (\$1.25). The underage operative was not asked for identification.
- 3. At the Commission hearing the Licensee, James Nejaime, while under oath accepted responsibility for the incident.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. As the licensee has been in business for twenty (20) years and has had no previous violations, the Commission issues a **WARNING**.
