Licensed Hospital Covid-19 Weekly Reporting Tool

In an effort to better understand, respond to, and report on the effect of the COVID-19 pandemic on the DMH licensed facilities and units, DMH is requiring weekly reporting by all DMH licensed facilities regarding several key elements. Each hospital/unit should report on Tuesdays with the answers to daily questions as of 12:01 AM of the reporting day. The number of staff testing positive and transfers to medical facilities/units should be for the prior week. The number of reported COVID-19 patient deaths should be all, whether occurring at the facility or for patients transferred for medical care, that were subsequently reported to the facility during the previous week. All data is to be reported by 1:00 p.m. on Tuesdays.
