Instructions

The Application for Reinstatement may be submitted to the Registry of Motor Vehicles (RMV) no sooner than 60 days prior to your reinstatement eligibility date. This is the date on which 10 years of your lifetime commercial disqualification has been served.

This application should only be completed by drivers who have received RMV approval of the *Initial Eligibility Review Application*. A response will be issued no later than 10 business days after the submission of a complete *Application for Reinstatement*.

RMV approval of your *Application for Reinstatement* allows you to move forward with the reinstatement process, but **it will not automatically reinstate your commercial driver's license (CDL)**. Final approval ends the lifetime disqualification on your driving record and allows you to move forward with the application, education, and testing process, **all of which must be completed and passed**, to obtain a commercial driver's license.

Eligibility Criteria

At the time of this application, you must meet all the following conditions and requirements to be considered for the Lifetime Disqualification Waiver Program:

- Served no less than 9 years and 10 months of your lifetime disqualification
- Have a driving record with no disqualifying convictions under 49 C.F.R. 383.51(b)-(e) or M.G.L. c. 90F, §9(A)(B) and (D) for the entirety of the disqualification period served
- Have been continuously eligible for a driver's license during the most recent 10-year period, excluding statutorily
 mandated non-payment suspensions unrelated to motor vehicle offenses, except as otherwise provided in 540
 CMR 2.06(9)(c)(5)
- Not currently prohibited in the federal Drug and Alcohol Clearinghouse ("DACH")
- Have a criminal background check, the results of which show no convictions, as defined by 49 CFR 383.5 and M.G.L. c. 90F, §1, involving alcohol, drugs, or controlled substances during the past 10 years, including but not limited to refusals to submit to a chemical test, analysis of the person's breath or blood, and dispositions of continued without a finding
- Currently possess an active Massachusetts Class D driver's license

Supporting Requirements

The following requirements must be met and proof of completion submitted with this application.

- Completion of a Massachusetts Department of Public Health substance abuse evaluation no sooner than 60 days prior to your reinstatement eligibility, or no sooner than 60 days prior to the submission of the Application for Reinstatement to the RMV, if you are past your reinstatement eligibility date. The Evaluation Report must be submitted to the RMV and must include the risk of substance abuse recidivism.
- Completion of the National Safety Council ("NSC") Defensive Driver Online course. Certificate of Completion
 must be no sooner than 60 days prior to your reinstatement eligibility date, or no sooner than 60 days prior to
 the submission of the Application for Reinstatement to the RMV, if you are past your reinstatement eligibility
 date.

Completion of the National Safety Council ("NSC") Attitudinal Dynamics of Driving course. Certificate of
Completion must be no sooner than 60 days prior to your reinstatement eligibility date, or no sooner than 60
days prior to the submission of the Application for Reinstatement to the RMV, if you are past your reinstatement
eligibility date.

Application for Reinstatement Approval Information

Drivers approved for reinstatement under this program must apply as a new commercial driver's applicant within 90 days of approval and are required to complete all testing, education, and licensing standards for current commercial learner's permit ("CLP") and CDL applicants. Note, for drivers who previously held a CDL, you are required to take NSC's Professional Truck Driver course and obtain a Certificate of Completion, prior to scheduling your commercial road skills test pursuant to 540 CMR 2.06(9)(c)(5)(b).

Applicants who have their CDL privileges reinstated through this application will be subject to permanent CDL disqualification if they are convicted of a major offense after reinstatement.
