PWS Licenses: All PWS licenses listed below are very small systems (VSS), full distribution (D) or full treatment (T), unless otherwise indicated as an Operator-In-Training (OIT). A combined PWS (C) license is one that was issued pre-1990 and includes both the Treatment and Distribution license at that Grade (for example, a C4 license is equivalent to holding both a D4 and T4 license).

Wastewater Licenses: Wastewater operator licenses are Municipal (M), Industrial (I) or Combined (C).
