DECISION

JM LITTLETON, INC. D/B/A LITTLETON'S ONE STOP LIQUORS
340 CONSTITUTION AVENUE, UNIT B-1-1
LITTLETON, MA 01460

JM Littleton, Inc. d/b/a Littleton's One Stop Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, May 6, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Quinn & Doyle's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Quinn & Doyle's Minimum Purchase Age Compliance Check Field Report, 3/24/2025;
2. ABCC Application Summary Review, Transfer of License Approved 8/3/2017;
3. Licensee's Stipulation of Facts.

FINDINGS OF FACT


1. On Monday, March 24, 2025, at approximately 6:48 p.m., Investigators Quinn & Doyle ("Investigators") conducted a compliance check at JM Littleton Inc. d/b/a Littleton's One Stop Liquors.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 12-ounce can of Bud Light beer for one dollar and fifty cents (\$1.50). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2017 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.


