DECISION

TAVERN IN THE SQUARE LITTLETON LLC D/B/A TAVERN IN THE SQUARE 495 GREAT ROAD

LITTLETON, MA 01460 LICENSE#: 02839-RS-0624 VIOLATION DATE: 3/24/2025

Tavern in the Square Littleton LLC d/b/a Tavern in the Square ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 2, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigators Quinn & Doyle's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Quinn & Doyle's Minimum Purchase Age Compliance Check Field Report, 3/24/2025;
- 2. ABCC Form 43 New License Approved, 8/16/2016;
- 3. Licensee Stipulation of Facts.

FINDINGS OF FACT

- 1. On Monday, March 24, 2025, at approximately 6:12 p.m., Investigators Quinn & Doyle ("Investigators") conducted a compliance check at Tavern in the Square Littleton LLC d/b/a Tavern in the Square.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 12-ounce bottle of Bud Light beer for six dollars and forty-two cents (\$6.42). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2016.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
