At 1:04 p.m., J. Hai called the meeting to order, and welcomed Lt. Governor Driscoll. All LGAC continuing and incoming members and attendees were introduced. J. Hai expressed appreciation for the service of all members and shared her appreciation for the close partnership between the Gov. Healey, Lt. Gov. Driscoll and the cities and towns of Massachusetts.
