#### SO VOTED

At 1:05 p.m., J. Hai called the meeting to order, and welcomed Lt. Governor Driscoll. All LGAC members and attendees introduced themselves. J. Hai expressed appreciation for the service of all members and shared her appreciation for the close partnership between Gov. Healey, Lt. Gov. Driscoll and the cities and towns of Massachusetts. Lt. Gov. Driscoll welcomed the members, and expressed appreciation and congratulations to Geoff Beckwith, who will be retiring in September, making this his final LGAC meeting. She presented G. Beckwith with a gubernatorial certificate and letter of appreciation, each signed by the Governor and Lieutenant Governor. G. Beckwith expressed his appreciation and thanks for the opportunity to coordinate LGAC for the past 31 years, approximately 211 consecutive meetings. The meeting proceeded with the swearing in of the 2023 LGAC members, with Lt. Gov. Driscoll administering the oath of office to all members in attendance. Members applauded. J. Hai then accepted a motion to adopt the minutes of the May 9, 2023 meeting, which was unanimously adopted. The Executive Committee then met (noted above). Then the full LGAC resumed its meeting and covered the items on the agenda: the state's budget, fiscal and economic condition, and presentations on the transportation and climate goals of the Administration.
