Statement of Interest

The Citizens United ruling has set a precedent which threatens the integrity of our democracy. Just as this case challenged BCRA which decreased the role of "soft money" and set limits on the use of "electioneering communications" now, a new response is imperative to overturn this disastrous decision. The impact of unregulated money flooding political elections strips the power away from "we the people" and grants the most influence to those with the biggest wallets let alone the threat of foreign money creeping in and corrupting our political process. A government for the people and by the people is central to a democracy and the ideals our forefathers sought in the drafting of the Constitution. The Supreme Court cited the First Amendment as protection against the F.E.C. regulating political campaign spending by organizations thus providing corporations with the same protections as individuals on the basis of free speech. However sound arguments can be made that contradict this ruling. Judge Nelson of the Montana Supreme Court writes "Freedom of speech is now synonymous with freedom to spend. Speech equals money, money equals democracy". His sentiments highlight the perversion of the First Amendment to favor big business over individuals, a direct contradiction to what constitutional founders envisioned. Nonetheless, I am confident a challenge asserting that money, a form of property cannot share the same privileges we do should be made.
