Amal Fuel, Inc. dba Drum Hill Gulf (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, August 14, 2012, regarding an alleged violation of 204 CMR 2.05(2), to wit: c.138, §34. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Capurso's Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigator Capurso's Compliance Check Field Report dated May 9, 2012; and
- 2. Licensee's Stipulation of Facts.
- A. Letter to Licensee from Lowell Police Department on Passing Their Compliance Check Investigation of May 4, 2012.

FACTS

- 1. On Wednesday, May 9, 2012 at approximately 7:41 p.m., Investigators Temple and Capurso conducted an investigation of the business operation of Amal Fuel, Inc. dba Drum Hill Gulf.
- 2. An underage operative working with investigators purchased an alcoholic beverage, a forty ounce (40 oz.) bottle of Budweiser beer for three dollars and four cents (\$3.04). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2), to wit: M.G.L. c. 138, §34. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
