DECISION

LCRC INC. D/B/A DUDLEY'S 19 MERRIMACK ST. LOWELL, MA 01852 LICENSE#: 0630-00069

VIOLATION DATE: 6/08/2018

HEARD: 9/11/2018

LCRC Inc. d/b/a Dudley's (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, September 11, 2018, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34C Possession of an alcoholic beverage by a person under twenty-one (21) years of age (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Investigator Di Cicco's Investigative Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FINDINGS OF FACT

- 1. On Friday, June 8, 2018, at approximately 12:10 a.m., Investigators Keefe and Di Cicco ("Investigators") conducted an investigation of the business operation of LCRC Inc. d/b/a Dudley's to determine the manner in which its business was being conducted.
- 2. Upon entering the licensed premises, Investigators observed a group of youthful appearing individuals in possession of alcoholic beverages. Investigators identified themselves and asked to see proof of legal age.
- 3. Underage #1, actual date of birth 11/30/1997 (age 20) was in possession of a vodka and cranberry juice. She stated that she did not have any identification and that she had not been asked for any identification when she entered the premises.
- 4. Investigators contacted the bartender on duty, Omar Phillip, and informed him of the violation and that a report would be filed with the Chief Investigator for review.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34C Possession of an alcoholic beverage by a person under twenty-one (21) years of age (1 count). Therefore, the Commission suspends the license for a period of three (3) days which will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
