### IX. NURSING HOME COVERAGE

## **National**

# 2001 46

According to the companies responding regarding nursing home coverage in 2001, nationally, **97.8%** of their long-term care insurance insureds had nursing home coverage. The average maximum daily nursing home benefit was **\$115.95** per day.

In the national group market, the percentage of insureds who had nursing home coverage was 100%; in the national <u>individual</u> market, 96.7% of insureds had nursing home coverage. In the national group market, the average maximum daily nursing home benefit was \$91.52 per day; in the national <u>individual</u> market, it was \$112.11 per day.

# 2004 47

According to the companies responding regarding nursing home coverage in 2004, nationally, **98.1%** of their long-term care insurance insureds had nursing home coverage. The average maximum daily nursing home benefit was **\$122.49** per day.

In the national <u>group</u> market, the percentage of insureds who had nursing home coverage was 100%; in the national <u>individual</u> market, 96.5% of insureds had nursing home coverage. In the national <u>group</u> market, the average maximum daily nursing home benefit was \$89.94 per day; in the national <u>individual</u> market, it was \$128.52 per day.

# Massachusetts

# <u>2001</u> 48

According to the companies responding regarding nursing home coverage in 2001 in Massachusetts, **98.7%** of their long-term care insurance insureds had nursing home coverage. The average maximum daily nursing home benefit was **\$133.40** per day.

In the Massachusetts group market, the percentage of insureds who had nursing home coverage was 100%; in the Massachusetts individual market, 97.7% of insureds had nursing home coverage. In the Massachusetts group market, the average maximum daily nursing home benefit was \$102.94 per day; in the Massachusetts individual market, it was \$152.62 per day.

# <u>2004</u> 49

According to the companies responding regarding nursing home coverage in 2004 in Massachusetts, **99.1%** of their long-term care insurance insureds had nursing home coverage. The average maximum daily nursing home benefit was **\$150.86** per day.

Thirty-four companies could respond to this question; the remaining companies either were no longer offering coverage nationally in 2001 or they provided insufficient information and their data were not included in the summary statistic.

Thirty-two companies could respond to this question; the remaining companies either were no longer offering coverage nationally in 2004 or they provided insufficient information and their data were not included in the summary statistic.

Thirty-four companies could respond to this question; the remaining companies either were no longer offering coverage in Massachusetts in 2001 or they provided insufficient information and their data were not included in the summary statistic.

Twenty-six companies could respond to this question; the remaining companies either were no longer offering coverage in Massachusetts in 2004 or they provided insufficient information and their data were not included in the summary statistic.

In the Massachusetts group market, the percentage of insureds who had nursing home coverage was 99.9%; in the Massachusetts <u>individual</u> market, 98.4% of insureds had nursing home coverage. In the Massachusetts group market, the average maximum daily nursing home benefit was \$93.87 per day; in the Massachusetts <u>individual</u> market, it was \$159.17 per day.
