Highlights:

- PCA program is the largest LTSS initiative under her oversight.
- Advisory group includes representatives from:
 - Health and Human Services
 - PCA Workforce Council
 - 1199 SEIU United Healthcare Workers East
 - o Massachusetts Senior Care Association
 - Massachusetts Senior Action Council
 - The Arc of Massachusetts
 - Disability Policy Consortium

Key Recommendations from the Advisory Group:

- Enforce overtime cap at 66 hours (projected savings: \$6.7M)
- Address fraud in the PCA program
- Eliminate paperwork burden for non-live-in members due to electronic timesheets (EVV) (projected savings: \$700K)

Program Data:

- PCA program served 56,000 members in SFY24 (26,000 in managed care)
- Annual cost has increased from \$1.2B (SFY20) to \$1.6B (SFY24), projected to reach \$2B by SFY27
- Cost increases attributed to serving a growing number of older adults
- State budget impact is significant; MassHealth must control growth and rates

Discussion Points:

- PCA program is the gold standard, no cap on hours for services like bathing/dressing
- Capping meal prep at 1 hour/day could save \$28M
- Administrative costs are low due to the model
- About 30,000 individuals live in skilled nursing facilities
- Wages for PCAs are increasing:
 - Entry wage: \$20/hour
 - \$25/hour for complex care starting January 2026
- Rate increases due to collective bargaining
- Need to align policy recommendations with health benchmarks
- Ongoing tension between rising needs and budget sustainability
