DECISION

ANDRE & ANDRE, INC. D/B/A FOUR SEASONS WINE AND LIQUORS 328 EAST STREET LUDLOW, MA 01056

Andre & Andre, Inc. d/b/a Four Seasons Wine and Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Guarino and Fleming's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Guarino and Fleming's Minimum Purchase Age Compliance Check Field Report, 5/23/2023;
- 2. Licensee's Stipulation of Facts;
- 3. ABCC Approval Cover Sheet, Transfer of License Approved, 4/22/2019.

FINDINGS OF FACT

- 1. On Tuesday, May 23, 2023, at approximately 5:52 p.m., Investigators Guarino and Fleming ("Investigators") conducted a compliance check at Andre & Andre, Inc. d/b/a Four Seasons Wine and Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one Bud Light beer, for one dollar and seventy-five cents (\$1.75). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2019.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
