DECISION

GERMANO INC. D/B/A FOUR SEASONS WINE & LIQUORS 328 EAST STREET LUDLOW, MA 01056

LICENSE#: 0632-00032

VIOLATION DATE: 05/16/2017 HEARING DATE: 06/20/2017

Germano Inc. d/b/a Four Seasons Wine & Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 20, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts;
- 2. Investigator Di Cicco's Compliance Check Field Report;
- 3. Photograph of Underage Operative; and
- 4. 24-ounce can of Bud Light beer.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Tuesday, May 16, 2017, at approximately 5:57 p.m., Investigators Kujawski and Di Cicco ("Investigators") investigated the business operation of Germano Inc. d/b/a Four Seasons Wine & Liquors.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a twenty-four ounce (24 oz.) can of Budweiser Light beer, for three dollars (\$3.00). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 15 years with no prior violations, the Commission issues a **WARNING**.
