## **DECISION**

KARUNA CORP. D/B/A MC HEALD LIQUORS 6 – 12 COMMERCIAL ST. LYNN, MA 01905

LICENSE#: 0638-00117 VIOLATION DATE: 08/11/2017

HEARING DATE: 12/05/2017

Karuna Corp. d/b/a Mc Heald Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, December 5, 2017, regarding an alleged violation of 204 CMR 2.05 (2) — Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 — Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Wilichoski's Report.

The following documents are in evidence:

- 1. Investigator Wilichoski's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

## **FACTS**

- 1. On Friday, August 11, 2017, at approximately 4:17 p.m., Investigators Wilichoski and Di Cicco ("Investigators") investigated the business Karuna Corp. d/b/a Mc Heald Liquors.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 6-pack of Bud Light beer, for six dollars (\$6.00). The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for 10 years with no prior violations, the Commission issues a WARNING.
