# DECISION

MOHAMMAD ISLAM D/B/A OLD TOWNE MARKET **8 POST OFFICE SOUARE** LYNNFIELD, MA 01940 LICENSE#: 0640-00020

**VIOLATION DATE: 3/18/2019 HEARING DATE: 6/11/2019** 

Mohammad Islam d/b/a Old Towne Market (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 11, 2019, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Di Cicco's Report.

#### **FACTS**

- 1. On Monday, March 18, 2019, at approximately 6:24 p.m., Investigators Temple and Di Cicco ("Investigators") investigated the business of Mohammad Islam d/b/a Old Towne Market.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Bud Light beer, for three dollars and eighty-nine cents (\$3.89). The underage operative was not asked for identification.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 10 years with no prior violations, the Commission issues a **WARNING**.
