**DECISION**

**THE NEXT ONE INC. D/B/A ALCHEMY  
1100 MARKET STREET  
LYNNFIELD, MA 01940

The Next One Inc. d/b/a Alchemy ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, May 27, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators DiCicco & Wilichoski's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators DiCicco & Wilichoski's Minimum Purchase Age Compliance Check Field Report;
2. ABCC Licensing Authority Certification, New License Approved, 7/13/2021;
3. Licensee's Stipulation of Facts.

**FINDINGS OF FACT**


1. On Monday, March 31, 2025, at approximately 6:15 p.m., Investigators DiCicco & Wilichoski ("Investigators") conducted a compliance check at The Next One Inc. d/b/a Alchemy.
2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one bottle of Bud Lite beer. The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2021.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
