## STATEWIDE ADDITIONAL OR ACCESSORIAL CHARGES

### EXTRA PICK-UP OR DELIVERY

An additional charge of \$59.40 will be assessed per stop or call at one or more places necessary for making additional pick-up after first pick-up or additional deliveries after first delivery.

### ELEVATOR, STAIR AND EXCESSIVE DISTANCE CARRY CHARGE

This item applies on Weight-Distance Shipments when elevators, stairs or excessive distances are involved in a pick-up or delivery.

1. ELEVATORS Where pick-up or delivery involves use of adequate elevator service up or down one or more flights, a charge will be assessed, viz:

One or more flights at origin  
or destination.....\$1.55 per cwt

2. STAIRS Where pick-up or delivery involves carriage up or down one or more flights of stairs, a charge will be assessed, viz:

Per each flight at origin.....\$1.10 per cwt  
Per each flight at destination.....\$1.10 per cwt

3. EXCESSIVE DISTANCES Where pick-up or delivery involves one or more carries, (an excessive distance carry is every 75 foot carry after the first 50 feet.)

Per each extra carry at origin.....\$1.10 per cwt  
Per each extra carry at destination.....\$1.10 per cwt

## STATEWIDE ADDITIONAL OR ACCESSORIAL CHARGES

### BULKY ARTICLES, LOADING AND UNLOADING CHARGES AND WEIGHT ADDITIVES

(Applicable on Weight-Distance Shipments)

When a shipment includes bulky articles as named below, the following additional loading and unloading charge or weight additive will apply.

LOADING AND UNLOADING CHARGES, in dollars and cents per article, include BOTH loading and unloading service and the handling and blocking of such article, and applies each time loading and unloading service is required (except for mover convenience).

**WEIGHT ADDITIVES:** When shipment includes travel camper trailers/mini-mobile homes (other than utility and pop-up trailers), boat, sailboat and/or boat trailer, the transportation charges will be based on the net scale weight of the shipment, plus a weight additive calculated in accordance with 1, 2, 3 and 4 below.

1. BOATS 14 ft. and over in length: 115 pounds per linear foot of total length.
2. BOAT TRAILERS any length: 75 pounds per linear foot of total length.
3. SAILBOATS 14 ft. and over in length: 125 pounds per linear foot of total length.
4. TRAVEL CAMPER TRAILERS/MINI-MOBILE HOMES (other than utility and pop-up trailers): 300 pounds per linear foot of total length

### BULKY ARTICLES, LOADING AND UNLOADING CHARGES AND WEIGHT ADDITIVES (Applicable on Weight-Distance Shipments)

- NOTE 1 - This weight additive will not apply to boats or sailboats of less than 14 feet in length, nor on canoes, dinghies, kayaks, sculls or skiffs of any size.
- NOTE 2 - When shipment contains two or more articles subject to the weight additive, the total weight additives for that shipment will be the sum of the individual additives for each bulky article calculated separately.
- NOTE 3 - In determining lengths for the purpose of this item all fractions of a foot will be disregarded.
- NOTE 4 - The length of boats or sailboats shall be determined by the straight center line distance between the top center point of the transom and a point perpendicular with the foremost part of the bow. Manufacturer's "length overall" or "center line length" shall apply as the correct length for the purposes of this item in lieu of physical measurement by carrier.
- NOTE 5 - The length of Boat trailers shall be the straight center line distance from a point equal to the rearmost part of the trailer to foremost part of the trailer tongue. Manufacturer's "length overall" shall apply as the correct length for the purposes of this item in lieu of physical measurement by carrier.

## STATEWIDE ADDITIONAL OR ACCESSORIAL CHARGES

### STORAGE-IN-TRANSIT AND WAREHOUSE HANDLING CHARGES

1. A storage rate of \$1.85 per 100 pounds shall be assessed for each 30 day period or fraction thereof each time a storage-in-transit service is rendered. The storage period will include the day the goods are placed in storage, but not the day goods are removed from storage. If goods are removed from storage on the same day they are placed in storage, one 30 day storage period shall apply.
2. A warehouse handling charge of \$2.80 per 100 pounds shall be assessed once each time shipment is placed in storage-in-transit.

### PICKUP OR DELIVERY TRANSPORTATION RATES ON STORAGE-IN-TRANSIT SHIPMENTS

PICKUP OR DELIVERY TRANSPORTATION RATES IN THIS ITEM APPLY ON STORAGE-IN-TRANSIT SHIPMENTS OR PORTIONS THEREOF WHEN:

Point of pickup or delivery and warehouse are BOTH located within the same municipality or within a distance of 30 miles or less. (For rates to apply when both points are not located within the same municipality or not within a distance of 30 miles or less, apply transportation rate in applicable rate section.)

Rates schedules in this item apply based upon location of warehouse.

Rates in this item are subject to the minimum weights as provided in rules of this tariff, and the pickup or delivery rate shall be based on the higher minimum weight as may be applicable, except for pickup or delivery of portions of the shipment, such rates shall be based on weight of the portion of shipment, subject to a minimum weight of 500 pounds or higher minimum weight as may be applicable.

NOTE - Rates in this item are in dollars and cents per 100 pounds applied to actual weight, plus weight additives when applicable (subject to minimum weights as provided in rules of property from origin to destination), but do not include additional services and charges. Break point indicates weight at which lower charge develops by use of lowest weight and applicable rate in next higher weight bracket.

## STATEWIDE ADDITIONAL OR ACCESSORIAL CHARGES

### (NC) VALUATION CHARGES

1. On shipments subject to HOURLY TRANSPORTATION RATES valuation charges provided for in this item will apply UNLESS shipper expressly releases the shipment to a value not exceeding 30 cents per pound per article.
    - (a) On shipments expressly released to a value EXCEEDING THIRTY (30) CENTS PER POUND PER ARTICLE (minimum valuation \$2,500.00) the valuation charge will be \$.50 per each \$100.00, or fraction thereof, of released or declared value.
    - (b) On shipments which also involve STORAGE-IN-TRANSIT, and ADDITIONAL VALUATION CHARGE of \$1.00 per each \$100.00 of released or declared value for each storage period of 30 days, or fraction thereof, in excess of the first period of 60 days will be assessed
  2. On shipments subject to WEIGHT DISTANCE TRANSPORTATION RATES valuation charges provided for in this item will apply UNLESS shipper expressly releases the shipment to a value not exceeding 60 cents per pound per article.
    - (a) On shipments expressly released to a value EXCEEDING SIXTY (60) CENTS PER POUND PER ARTICLE, the valuation charge shall be 50 cents per each \$100.00, or fraction thereof, of released or declared value.
    - (b) On shipments which also involve STORAGE-IN-TRANSIT, and ADDITIONAL VALUATION CHARGE of \$1.00 per each \$1,000.00 of released or declared value for each storage period of 30 days, or fraction thereof, in excess of the first period of 60 days will be assessed.
- NOTE - If the shipper wishes to avoid these additional charges he must agree that if any articles are lost or damaged, the mover's liability will not exceed 30 cents per pound for the actual weight of any lost or damaged article or articles in the shipment on shipments subject to Hourly Transportation rates or 60 cents per pound for the actual weight of any lost or damaged article or articles in the shipment on shipments subject to Weight Distance Transportation Rates.
