DECISION

ALL SEASONS TABLE LLC D/B/A ALL SEASONS TABLE 62-64 PLEASANT STREET MALDEN, MA 02148 LICENSE # 00112-RS-0646

All Seasons Table LLC d/b/a All Seasons Table ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, May 27, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Guarino & Fleming's Minimum Purchase Age Compliance Check Field Report.

- 2. ABCC 2016 License Renewal Application;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- On Monday, April 7, 2025, at approximately 6:17 p.m., Investigators Fleming & Guarino ("Investigators") conducted a compliance check at All Seasons Table LLC d/b/a All Seasons Table.
- 2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one bottle of Bud Light beer. The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
