## **DECISION**

Fraternal Order of Eagles Malden Aerie #893 (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, May 6, 2014, regarding an alleged violation of 204 CMR 2.05 (1): Permitting Gambling. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Teehan's Report.

The following documents are in evidence:

- 1. Investigator Teehan's Violation Report dated November 20, 2013;
- 2. Licensee's Stipulation of Facts; and
- 3. Photocopy of Video Game score card.

There is one (1) audio recording of this hearing.

## <u>FACTS</u>

- On Wednesday, November 20, 2013, at approximately 2:00 p. m., Investigators Keefe and Teehan conducted an investigation of the business operation of Fraternal Order of Eagles Malden Aerie #893 to determine the manner in which its business was being conducted.
- 2. Investigators entered the licensed premises, identified themselves to the bartender on duty, Rocky Brooks, and inspected the bar area.
- 3. Investigators observed four electronic video devices, in the back of the bar area. Also in plain view were several 4" by 5" pads of paper printed with Video Game amusement only, machine number, number of credits towards gift card of choice, no cash prizes.
- 4. Next to the cash register, investigators observed an index card with a hand written note which indicated machine#1, 11/18, and 320-80.
- 5. Investigators interviewed Mr. Brooks who stated that the Licensee does payoff for winnings on the electronic video devices with gift cards. He explained the 320-80 notation on the index card indicates that 320 credits won and \$80.00 paid out in gift cards.
- 6. Based on their training and experience, investigators know that the standard payoff rate for illegal gambling devices in Massachusetts is twenty-five cents per point.

- 7. Mr. Brooks further stated that the vendor [for the devices] is Able Vending and the split is 50% of net revenue to the club and 50% net revenue to Able Vending.
- 8. Investigators made the following observations, which based on their training and experience, indicate that these electronic devices were being utilized as gambling devices:
  - > Each device had markings which indicated "for amusement only".
  - Each device accepted dollar bills ranging from \$1, \$5, \$10, \$20.
  - After inserting US currency into the device, an investigator selected the number of credits (the amount to bet). The device "registered" the bet by displaying the number of credits selected.
  - Each device had the capability to double up the bet by selecting a double-up button.
  - Each device had a "knock off" mechanism in the form of a push button on the back of the machine, or of a ticket button on the front console, which when pressed, reset the winning credits to zero.
- 9. Investigator Keefe inserted one U.S. dollar into Crazy Bugs 2, Triple Fever, and Fever Game machine which registered a bet in each device. He then pressed a button on the back of the device (the knock-off switch) and investigators observed the credits reset to zero.
- 10. Investigator Keefe inserted one U.S. dollar into the New Fruit Bonus 96 machine which registered the bet. He then placed a coin on two bolts (the knock off switch) on the side of the device and investigators observed the credits reset to zero.
- 11. Investigators advised Mr. Brooks of the violation and that a report would be submitted to the Chief Investigator for review.

## **CONCLUSION**

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (1): Permitting Gambling. Therefore, the Commission suspends the license for five (5) days of which two (2) days will be served and three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur. In addition, the licensee must not possess in or on the licensed premises any automatic amusement device or video poker machine.
