**DECISION**

AMDA Convenience Corp. d/b/a Town Food Mart ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple and David's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Temple and David's Minimum Purchase Age Compliance Check Field Report, 5/17/2023;
2. Licensee's Stipulation of Facts;
3. ABCC Licensing Authority Certification, New License Approved, 12/29/2021.

There is one (1) audio recording of this hearing.

**FINDINGS OF FACT**

1. On Wednesday, May 17, 2023, at approximately 6:00 p.m., Investigators Temple and David ("Investigators") conducted a compliance check at AMDA Convenience Corp. d/b/a Town Food Mart.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25 oz. Budweiser beer, for two dollars and ninety-nine cents (\$2.99). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2021.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
