Blazin Wings, Inc. d/b/a Buffalo Wild Wings ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, November 14, 2023, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Temple and David's Minimum Purchase Age Compliance Check Field Report.

FINDINGS OF FACT

1. On Wednesday, May 17, 2023, at approximately 7:09 p.m., Investigators Temple and David ("Investigators") conducted a compliance check at Blazin Wings, Inc. d/b/a Buffalo Wild Wings.
2. An underage operative, working under the supervision of Investigators, was served an alcoholic beverage, one Bud Light draft beer. The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 12 since 2013.

CONCLUSION


Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
