DECISION

K LIQUOR CORP. D/B/A DUB'S DISCOUNT LIQUORS 30 CHAUNCEY STREET MANSFIELD, MA 02048 LICENSE#: 90920-PK-0652

K Liquor Corp. d/b/a Dub's Discount Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, June 17, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Smith & McDonough's Minimum Purchase Age Compliance Check Field Report.

- 2. ABCC Licensing Authority Certification re: Transfer of License;

FINDINGS OF FACT

- On Monday, March 31, 2025, at approximately 4:42 p.m., Investigators Smith & McDonough ("Investigators") conducted a compliance check at K Liquor Corp. d/b/a Dub's Discount Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 16-ounce can of Bud Light beer for two dollars and thirty cents (\$2.30). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2024.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a WARNING.
