**DECISION**

**DN LIQUORS CORP. D/B/A VILLAGE LIQUOR STORE  
22 BESSOM STREET  
MARBLEHEAD, MA 01945

DN Liquors Corp. d/b/a Village Liquor Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, September 23, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kenny & Guarino's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Kenny & Guarino's Minimum Purchase Age Compliance Check Field Report;
2. ABCC Form 43 Transfer of License Approval, 11/10/2005;
3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

**FINDINGS OF FACT**

1. On Monday, June 2, 2025, at approximately 5:10 p.m., Investigators Guarino & Kenny ("Investigators") conducted a compliance check at DN Liquors Corp. d/b/a Village Liquor Store.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Bud Light beer for nine dollars and ninety-nine cents (\$9.99). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2005 with no previous violations.

### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
