**DECISION**

**MOOKIE'S AT MUGFORD LLC D/B/A HALEY'S WINE & SPIRITS  
112 WASHINGTON STREET  
MARBLEHEAD, MA 01945

Mookie's at Mugford LLC d/b/a Haley's Wine & Spirits ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, October 7, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kenny and Guarino's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

1. Investigators Kenny & Guarino's Minimum Purchase Age Compliance Check Field Report, 6/2/25;
2. ABCC Licensing Authority Certification, Transfer Approved 7/21/2022;
3. Licensee Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

1. On Monday, June 2, 2025, at approximately 5:39 p.m., Investigators Kenny & Guarino ("Investigators") conducted a compliance check at Mookie's at Mugford LLC d/b/a Haley's Wine & Spirits.
2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Bud Light beer for eight dollars and twenty-five cents (\$8.25). The underage operative was not asked for identification.
3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2022.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
