N K Market, Inc. dba Post Road Pantry (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 29, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Licensee's Stipulation of Facts; and
- 2. Investigator Doyle's Compliance Check Field Report dated June 17, 2013;
- 3. Compliance Check Guidelines; and
- 4. Photo of Underage Operative.

### **FACTS**

- 1. On Monday, June 17, 2013, at approximately 5:45 p.m., Investigators Bailey and Doyle conducted an investigation of the business operation of N K Market, Inc. dba Post Road Pantry.
- 2. An underage operative, working with investigators, purchased an alcoholic beverage, a twenty-four ounce (24 oz.) can of Budweiser Light beer for two dollars and forty-nine cents (\$2.49). The underage operative was not asked for identification.

## **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
