Acton Annual Town Meeting 2017

It's that time again: Annual Town Meeting preparation. Annual Town Meeting is the time that we set the budgets and deal with known capital items. At this time, the warrant is not yet set, meaning some articles may be removed and some changed.

There are two articles of special interest, both dealing with a company named Insulet Corporation. Full disclosure: I'm a member of the Economic Development Committee which is in total agreement with this proposal.

Insulet is asking for the Town to give them a TIF (Tax Incentive Financing) agreement and to change the zoning of 100 Nagog Park from Office Park to Manufacturing. Insulet manufactures a small device that provides diabetics with their needed dose of insulin in a manner that does not require pumps or needles. For diabetics, this device is a breakthrough in their treatment.

The zoning change is for a building that has not been occupied for approximately 15 years. Insulet plans to build an addition to 100 Nagog Park for their manufacturing needs as well as move their administration from Billerica to Acton. The manufacturing process is a "closed" sterile environment that does not use water or expel fumes. There is waste that is, by law, picked up by a private firm and disposed of at facilities that deal with medical waste.

Insulet expects to employ around 1,000 people at the Acton facility. In addition to those that come with them from Billerica there will be new hires as Insulet intends to close their manufacturing unit in China. This consolidation will allow Insulet to have their administration and manufacturing at the same location.

In a TIF a town "forgives" the property tax on a building for a set period of time. In this case Insulet will pay no property tax on the new construction for the first five years, though they will pay property tax on the unimproved 100 Nagog Park building. After the initial period the property tax paid on the new building will increase over a period of years from 25% to 50% to 75% to 100% of the assessment. Meanwhile Insulet will continue to pay the property taxes on the existing structure.

The business owners in the Nagog Park Mall have been contacted and are in favor of such revitalization to the area.

I am working on a Warrant Meeting, open to the public, where these and other warrant articles can be discussed. The Warrant Meeting will be at Acton Town Hall Room 204 on Wednesday March 22 at 7:30.

March Social Policy Report

Groups providing social services in the Acton-Boxborough area are increasing their effectiveness by meeting monthly to share their plans, avoid duplication of services, and reach beyond their membership to publicize their activities.

The R.I.T.E Project Collaborators, originally brought together with a "Resident Isolation To Engagement" grant from CHNA 15, met on January 24th and decided to continue their activities after the grant ends as "Healthy Acton". This new name, which reflects the sponsorship of the Acton Health Department, is actually a misnomer because group members represent a wide range of Acton and Boxborough services such as schools, churches, health providers, and emergency services. A website,

<u>http://www.healthyacton.org/</u>, will feature community resources and list upcoming activities.

- A new community group, called Acton-Boxborough Cares, is being formed to focus on Behavioral Health issues, including suicide prevention, that effect all ages. The idea first emerged during a meeting of the ABUW grantees. Danny's Place and A-B Schools District representative Dawn Bently will be looking for cooperation from community groups.
- We would like to point out that LWV-AA has submitted "Behavioral Health Concerns" to the State League as an Action Priority for Program Planning in 2017-2019. Specifically, we have recommended the League look into measures that provide for training of police and emergency service providers, improve access to care, seek insurance parity, and explore the overlap between mental health issues and criminal justice reform.
- A "Beating the Winter Blues Workshop" on January 30th featured an Eliot Center therapist who specializes in treating older adults. She said 20 to 30 minutes outside

each day, or at least sitting in a sunny window, might help boost serotonin levels, and maintaining a regular schedule of social engagements (at least a phone call every day) could improve one's mood. She urged people to include one meaningful activity every day, such as helping a friend in need.

• A two-part Fall Prevention Workshop is scheduled for February 28th and March 7th, from 10:30 am to noon in Town Hall. The workshop will look into why falls occur, how to prevent them, and suggest ways to reduce risk in your home. Simple chair exercises to increase balance will be taught, and their effectiveness measured in the second class after a week's practice. Signup with Sheryl Ball of the Acton Health Dept.:

There was a Safety Net meeting on January 26th, led by Acton Community Services coordinator Laura Ducharme. A diverse group of representatives of churches, government agencies, and non-profit service providers from the Acton-Boxborough area shared their concerns and activities.

- The speaker was Sally Mendoza of the Neighbor Brigade, a group of community volunteers who provide temporary assistance to people who are in crisis due to a health concern, accident, high-risk pregnancy or birth, injury or death in the family. Most of the help focusses on day-to-day needs such as delivering meals, simple housekeeping chores, and walking the dog. One current case involves a mother who broke her foot and couldn't get her children to their bus stop; volunteers have stepped in to transport the children twice a day.
- After a volunteer applies and is accepted (a CORI check is required), they can visit <u>www.neighborbrigade.org</u> and sign up to provide the help. Individuals seeking services can also use the site. Though the organization has 27 chapters in Massachusetts, the Acton-Boxborough group was just organized last September and is looking for members.

Take Action on Behavioral Health Legislation

Many read the Boston Globe Spotlight series <u>The Desperate and the Dead</u> about the behavioral health system in Massachusetts. While sensational, it did bring attention to a network that needs shoring up.

"Behavioral health" is the nationally accepted term covering mental illnesses and substance use disorder. "Substance Use Disorder" includes substance addiction.

At last year's national LWV convention, a position on behavioral health was adopted by concurrence. Specifics on the position are available at this link:

The League's positions on basic health care and criminal justice reform also tie in to efforts in this area.

Every League now has a place to stand to spearhead local change to help those living with mental health and substance abuse concerns.

Other organizations track legislation that affects behavioral health. The National Alliance on Mental Illness (NAMI) is a national grass roots organization that serves to educate, support, and advocate on behalf of individuals and families living with mental health concerns. NAMI Massachusetts offers a priority list of issues and bills that will help bridge the gaps in our state's behavioral health system. Below is a cut and paste excerpt from the NAMI Massachusetts executive summary of legislative priorities for 2017-2018. The full text is available at http://namimass.org/contact/advocacy. Once on the advocacy page, to view the specific bills being recommended, select the "Actions" tab. There you will note that Senator James Eldridge is the sponsor of one of the bills.

Please consider lending your personal support to these efforts by visiting, phoning, or writing an email or letter to your State Rep or State Senator asking them to support the following bills. DMH Funding: NAMI Mass' #1 priority has always been and continues to be advocating increased funding to the Department of Mental Health (DMH) budget. NAMI Mass is encouraged that the trend over the past several years has been first to restore devastating cuts and then, more recently, modest increases in critical funding for DMH services.

A Comprehensive, Sustainable Police and First Responder Mental Health Training Program: Throughout the Commonwealth, people with mental illness and substance use disorders are arrested and incarcerated at disproportionate rates, leading to devastating consequences for individuals, families, and communities. Proven strategies can reverse this trend by focusing on the initial point of contact with law enforcement, diverting people who pose no safety risk to appropriate treatment instead of arrest. These strategies consist of two main components: quality mental health training for police officers and collaborations across disciplines. Pockets of excellence and innovation around the state have successfully diverted people with mental illness from jails and prisons and have increased access to services. Many more are eager to move in this direction as well.

Bridgewater State Hospital: For decades, the Commonwealth has asked its state prisons to take responsibility for people who have human services issue like mental illness and substance use disorders. In virtually every other state in the country, these same individuals would be cared for by the state mental health and public health systems. People who have not been convicted of a crime and all those who meet the very strict criteria for civil commitment must be the sole responsibility of our state mental health and public health systems, not kept at Bridgewater State "Hospital" as is the current practice in Massachusetts.

Expand Emergency Service Provider Coverage (ESP's): An ESP is a community-based and recovery-oriented service. It provides behavioral health crisis assessment, intervention, and stabilization services for people with psychiatric illness. ESP teams have trained psychiatric clinicians that are "mobile" and will travel to the location of the crisis— home, school or community locations. Currently, individuals on MassHealth are covered by ESP services but many people with private health insurance do not have access to these essential and oftentimes life-saving services.

Reimbursement Rates for MassHealth for Hospitals: NAMI Mass supports a significant and sustainable increase to MassHealth's budget so hospitals can afford to provide inpatient psychiatric services within their communities, and so out-patient mental health clinics can remain open and operating. It is unfair and inhumane to force families to wait for days before they can find an inpatient bed for a loved one who is suffering. It is unacceptable that mental health clinics are closing and reducing their patient load when the need is so great. Behavioral health needs cannot be met when MassHealth reimbursement rates are so inadequate. NAMI Mass calls for a comprehensive remedy to this problem in the FY2019 budget by increasing funding to ensure adequate access to critical hospital and outpatient services throughout the Commonwealth of Massachusetts.
