General Description

The Massachusetts Office of Business Development serves as the umbrella organization for all business development activity on behalf of the state. The Commonwealth is divided into six regions, each led by a regional Director who reports to Executive Director.

The Massachusetts Office of Business Development offers a range of expertise and services to help business flourish in Massachusetts. The Massachusetts Office of Business Development's staff operates regionally statewide, so that the Agency can provide on-the-ground knowledge and viable connections for businesses. The Massachusetts Office of Business Development works closely with the private and public sectors to coordinate a range of resources, including financing opportunities, workforce training and site selection.

The Massachusetts Office of Business Development oversees and manages the Economic Development Incentive Program (EDIP), a tax incentive program designed to foster full-time job creation and to stimulate business growth across the Commonwealth. Companies eligible for the Economic Development Incentive Program may receive state and local tax incentives in exchange for full-time job creation, manufacturing job retention and private investment commitments.

The Massachusetts Office of Business Development's mission is to strengthen the economy of Massachusetts by promoting job growth and retention, specifically with Economic Development Incentive Program which is designed for eligible businesses that seek to relocate or expand their operations in Massachusetts; and by facilitating access to resources, helping businesses thrive in the state.
