I would like to share my concerns with the Department of Public Health about the expansion plans of Mass General Brigham and their intent to develop an ambulatory surgery center in Woburn.

I am an orthopedic surgeon at Agility Orthopedics. I have practiced out of our Stoneham office for the last 13 years. I work out of 2 hospitals in this community, Melrose Wakefield Hospital and Winchester Hospital. I have practiced orthopedics in Massachusetts for 18 years. I attended college at Tufts University. My fellowship in sports medicine was at the New England Baptist Hospital. So I am very familiar with the area and the medical community.

I am concerned about the proposed scope of expansion of Mass General Brigham in this area. I think it will increase the cost of care in this community without adding value for routine care.

In 2015, the Commonwealth halted then Partners HealthCare's acquisition of the Hallmark Health System – now MGB and Melrose Wakefield Healthcare, respectively – due to concern about market power and the negative impact to consumers.

I supported the acquisition at the time because I saw MGB using its deep pockets to support the community mission that was already in place to provide healthcare to all including those with mental illness, those with addiction and those with poor insurance plans. Now, five years later, MGB is looking to come into the same community, but this time with the ability to pick and choose how they want to interact with the community. They can reach out to the well insured, mobile and educated patients, leaving the financial burden of managing the rest of the

community to the community hospitals. Running our hospitals is normally a difficult proposition, but under these conditions it may become impossible. If the acquisition of Melrose Wakefield Healthcare five years ago was a bad idea, then this is even worse.

MGB's narrative is that they are pursuing this expansion for the convenience of their patients. But we all know that once this facility is built in Woburn they will use their deep pockets and reputation to attract primary care physicians away from community health systems and have them bring their patient panels with them. They will also bring specialists into the community to attract away procedures that help to keep community hospitals afloat.

We have been working hard in the community to provide excellent care at lower costs. Melrose Wakefield has even gone into a partnership with its physicians and Shields to build a free standing ambulatory surgery center in Medford to provide excellent care at a fraction of the cost of what the Applicant has proposed.

I appreciate having major academic centers 15 miles down the road to help treat my patients with complex problems that are beyond the scope of community care in the area. This expansion will route people away from our community resources for routine care that is best done in community hospitals, clinics and surgery centers.

I specifically request that the Department of Public Health require the Health Policy Commission to conduct theindependent cost analysis to show us the impact of building this facility in Woburn, MA. I also request that additional public hearings be scheduled after the independent cost analysis has been conducted so the people of this community have a chance to participate in the decision-making process in an informed manner.

My name is Ada, a resident in Malden. Thank you for this opportunity to testify. I am writing to express my concerns related to the Massachusetts General Brigham's proposed new ambulatory expansion site that will be located in Woburn; DoN 21012113-AS. This multi-million dollar expansion would have a massive negative impact on the cost of care and the ability for local community health care organizations to continue to support our residents.

I agree that great health care, delivered in the community for a lower cost is what is best for residents of the Commonwealth. However, I believe that the expansion of Mass General Brigham (MGB) ambulatory services into Woburn will increase the cost of care in our community without increasing the quality of care for patients. MGB has a track record of merging, acquiring or pushing out community health care systems and then pricing services at a higher cost, increasing the financial burden placed upon patients throughout the Commonwealth.

Woburn is not a medically underserved community. Woburn is already well-serviced by high-quality, low-cost healthcare providers. Approving MGB's application to expand into our community will threaten the financial viability of local practitioners and smaller health care systems, replacing quality care offered at affordable rates by local medical institutions with the same services at higher price points. Any increases to the cost of care are unacceptable and untenable in an already highly expensive market. I believe that the expansion of Mass General Brigham (MGB) ambulatory services into Woburn will threaten essential local jobs and the financial viability of critical community care institutions.

I believe that the expansion of Mass General Brigham (MGB) ambulatory services into Woburn is likely to worsen existing health disparities. The proposed MGB sites target higher income, predominantly white, mobile, commercially insured populations already served by existing providers. The proposed locations are not easily accessible to residents of low-income communities with barriers to health care, leaving

access and the needs of many residents behind. MGB will be drawing commercially insured patients away from local community providers who rely on that care to subsidize patients that are insured by public programs, such as Medicare or Medicaid, or who are uninsured. Our local community providers will continue to serve those patients even if their commercial volume is negatively impacted by MGB. However, these same providers may be financially forced to close much needed medical services,

resulting in reduced safety net care for our communities' most vulnerable patients, while the most privileged migrate to MGB.

In closing, I truly believe in health care cost-containment, partnership, and the spirit of equitable collaboration where all sizes and types of healthcare organizations work together to benefit their communities. I respectfully ask MDPH to closely look at this request and do a full data analysis and hold additional public hearings. Furthermore, consider the fact that the real opportunity is to optimize the use of existing health care services rather than approve new services that are not needed.

Testimony at DPH Public Hearing on MGB's proposal to build medical facilities in Woburn, MA
Thursday, March 25, 2021

Mr. Chairman, my name is Alan Macdonald. I live at 7 Wainwright Road in Winchester. I am a former trustee, and a former President of Melrose Wakefield Healthcare, then known as Hallmark Health; but I am no longer affiliated with any healthcare network, and I speak for myself at this public hearing.

My testimony is to say I do not believe there is a need for the services proposed by MGB for the Woburn site, and, if DPH were to determine there is a need, I believe the services proposed by MGB would be more costly for this area than is now the case.

Mr. Chairman, from 2014 to 2016, in my then capacity for Hallmark Health, I heard repeatedly from DPH that a move by Mass General Hospital's network into this local area would raise the overall costs of health care, and that Hallmark Health's ability to provide community healthcare at reasonable costs would have to be done outside an affiliation with MGH. It took a little while for that advice to take hold, because Hallmark Health was in an exclusive arrangement with MGH at that time, but we did take it as a directive to find a different arrangement that would provide the resources and the competitive strength to allow community healthcare to survive in this area, with high quality at reasonable costs.

After hearing from a number of healthcare networks interested in serving patients in this area, Hallmark Health merged, as you know, with Tufts Medical Center and Circle Health of Lowell. That merger, now in its fifth year, has provided vigorous competition around Greater Woburn, and because of the competition, this area has the skill, capacity and cost management to do what MGB proposes in its current petition to provide surgical services and cost savings.

However, as DPH determined only a half-decade ago, over similar arguments for cost-savings as now expressed by MGB, approval of this proposal would not result in cost saving outcomes. Others have spoken to the weaknesses behind predicted cost savings in this proposal, so I won't repeat those points. Only to say, first, I do not believe this proposal shows any need in the Greater Woburn area that is not being addressed and served by existing community networks, particularly the Lahey/Winchester and Wellforce/Melrose Wakefield networks. Secondly, if DPH were to determine there may be such a need, prior review by DPH in similar circumstances indicates there is no overall cost benefit to be gained by approving the proposal considered at this public hearing.

My group has an office at 88 Montvale Avenue, literally only a block from the site. We have well established ,long term and personal important Doctor- Patient relationships that clearly would be jeopardized by this project. We also have an ongoing relationship and responsibility to the surrounding communities in Stoneham, Woburn and Winchester as opposed to the generic- style inherent in the proposal.

I would like to refute the MGB talking points that were presented.

- 1) Need- The area is already saturated and well served by existing primary care, speciality services, imaging and surgical services.
- 2) Lower Cost- As had been pointed out- MGH has historically considerably higher costs across the board for medical and surgical services, and transferring costs to an outpatient center that only duplicates existing services will only raise medical costs for the State.
- 3) Integration- Already accomplished by Winchester Hospital/ BILH and done well and efficiently
- 4) Quality and Safety- Winchester Hospital has been awarded repeatedly for its leadership in high quality, state of the art and care with an eye on safe practices and top notch, award winning Nursing care

Oral Testimony re: Mass General Brigham Determination of Need Application - March 25, 2021

Introduction

- Good morning, my name is Anna Tonseth. I appreciate the opportunity to share my concerns with the Department of Public Health about MGB's community expansion plans and intent to establish an outpatient center in Woburn.
- I currently serve as a Business Development Analyst for Shields Health Care Group. Being affiliated with an outpatient services provider, both in imaging and ambulatory surgery, I have significant concerns about how MGB's proposed expansion will impact the cost of care and other healthcare providers in the region.

Market Demand and Cost of Care

- After substantial analysis, I believe there is not enough community demand to warrant MGB's proposed expansion of imaging and ambulatory surgery services in Woburn.
- Given that there are 39 MRI units with DON approval in the primary service area and slightly
 outside, the patient panel within the region has ample access to MRI service offerings, with
 many being on Independent Diagnostic Testing Facility rates. 12 of the 39 MRI units noted are
 currently owned and operated by MGB such that patients wanting to receive care within the
 network have the ability to do so easily.
- As such, there is quite frankly not enough demand to justify the addition of not just one, but two MRI units in Woburn.
- In addition, throughout the DON MGB continually pointed to the reduction in scan times due to improvements in technology. Multiple times, including in a presentation to community members, MGB noted that scan times would be between 15-30 minutes. However, in actual capacity calculations, MGB utilized a scan time of 45 minutes. Not only does this discrepancy highlight MGB's underestimate of capacity, but also signifies the need for additional data from MGB to prove the need for multiple units.
- On the ambulatory surgery side, Woburn is already well-served by high-quality, low-cost healthcare providers, including the ambulatory surgery center owned and operated by Melrose Wakefield, Shields ASC, and multiple community physicians. The DoN program's regulation concerning ambulatory expansion was designed by DPH to protect community hospitals from the proximate development of ambulatory surgical centers without the community hospital's consent or participation. Approving MGB's application would threaten the future of community hospitals and other low-cost providers in the area.

Concluding Argument

- On another note, the primary service outlined by MGB includes zip codes previously outlined in the Somerville DON Application approved February 2020. I would like to ask DPH to ensure scan volume is not being double counted.
- In order to accurately understand the impact of this proposal, I also suggest that an additional public hearing be scheduled for after the independent cost analysis has been conducted. Thank you for your time.
