My name is Elizabeth Hart, Founder & Executive Director of Tailored for Success, Inc. Thank you for

this opportunity to testify. I am writing to express my concerns related to the Massachusetts General

Brigham's proposed new ambulatory expansion site that will be located in Woburn; DoN 21012113-AS.

This multi-million dollar expansion would have a massive negative impact on the cost of care and the

ability for local community health care organizations to continue to support our residents.

I agree that great health care, delivered in the community for a lower cost is what is best for residents of

the Common wealth. However, I believe that the expansion of Mass General Brigham (MGB) ambulatory

services into Woburn will increase the cost of care in our community without increasing the quality of

care for patients. MGB has a track record of merging, acquiring or pushing out community health care

systems and then pricing services at a higher cost, increasing the financial burden placed upon patients

throughout the Common wealth.

MOB will be drawing commercially insured patients away from local community providers who rely on that care to subsidize patients that are insured by public programs, such as Medicare or Medicaid, or who are uninsured. Our local community providers will continue to serve those patients even if their commercial volume is negatively impacted by MOB. However, these same providers may be financially forced to close much needed medical services, resulting in reduced safety net care for our communities' most vulnerable patients, while the most privileged migrate to MOB.

In closing, I truly believe in health care cost-containment, partnership, and the spirit of equitable collaboration where all sizes and types of healthcare organizations work together to benefit their communities. I respectfully ask MDPH to closely look-at this request and do a full data analysis and hold additional public hearings. Furthermore, consider the fact that the real opportunity is to optimize the use of existing health care services rather than approve new services that are not needed.

I am writing in **support of the MGB expansion to Woburn.** As an MGB patient, there is a glaring disparity in medical care in the Woburn area. I am hopeful that the determination of need for the MGB expansion is more heavily weighted on local resident and patient comments rather than on local hospital and business comments and scare tactics. Clearly the local hospitals and businesses do not want competition in their backyard, however if they truly care about patients and keep healthcare at the core of this discussion, they will see that the MGB expansion is a necessity for this area. This expansion allows for consumer choice and most importantly, access for those of us choosing to receive care within the MGB system.

Aside from the Lahey network, there is no real choice for medical care in Woburn and surrounding areas. Lahey is out of my insurance network and costs me exponentially more out of pocket. From my experience, most local hospitals do not have as many treatment options as those offered by the MGB system. For example, my mother was recently diagnosed with breast cancer. Her first opinion was at a local Lahey-affiliated hospital. My name is Loretta Kemp and I appreciate this opportunity to testify regarding the above. I am writing to express concern about Massachusetts General Brigham's proposed new ambulatory expansion site to be located in Woburn (DoN 21012113-AS).

My first concern is that although this multimillion-dollar state of the art expansion would bring high quality care to the suburbs, it will also have a negative impact on the cost of care. Data have shown that this kind of expansion by major Boston hospitals significantly drives up the cost of health care for local residents. Not only does the new entity charge more for services, but it also impacts existing healthcare service providers. Specifically, independent providers tend to close their private practices and join the new mega-group that charges higher fees. The result is increased healthcare costs over an ever-expanding geographical area. At a time when the focus has finally been shifted to equity of access to quality healthcare services, this seems to be counterproductive and even insensitive. That is, it *increases* the financial barrier to equitable access. At a time when COVID-19 repercussions have wreaked havoc on both household and business finances, this seems a very untoward action.

Secondly, related to the issue of equity of access to healthcare is the impact on service providers. Local community healthcare organizations have been, and continue to be, the hallmark for providing quality healthcare at more affordable prices. In addition, this COVID-19 pandemic has highlighted the role that trust plays in accessing / using available services. Invariably, trust is built through *personal* connections between and among "neighbors," *i.e.*, healthcare workers that are familiar to (and with) their customers—local residents. Often, in local communities an ongoing relationship spans generations. Too often, in these large conglomerate mergers, local healthcare providers / staff are replaced. The connections and trust that had formerly built up over the years is lost. This dis-connect most impacts vulnerable communities that already suffer inequitable treatment and treatment options, even when they are accessed.

Thirdly, quality health care is already provided to the Woburn area, through recent mergers of local / regional healthcare providers and large organizations such as Lahey and Tufts Medical Center. These have enhanced and stabilized the quality of services provided *without* significantly reducing other local healthcare providers. Therefore, high quality services are available at more affordable costs—a win-win for residents.

Fourthly, Woburn is not a medically underserved community. It is already well-serviced by high-quality, low-cost healthcare providers. Approving MGB's application to expand into our community will threaten the financial viability of local practitioners and smaller health care systems, replacing quality care offered at affordable rates by local medical institutions with the same services at higher price points. Any increases to the cost of care are unacceptable and untenable in an already highly expensive market. I believe that the expansion of Mass General Brigham (MGB) ambulatory services into Woburn will threaten essential local jobs and the financial viability of critical community care institutions. Finally, the proposed MGB sites do not target the most vulnerable residents of the area who already have limited options to obtaining quality health care. The proposed locations are not easily accessible to residents of low-income communities, creating yet another barrier to equitable healthcare services—rather than *reducing* barriers. In actuality, MGB will be drawing commercially insured patients away from local community providers who rely on that care to subsidize patients that are insured by public programs, such as Medicare or Medicaid, or who are uninsured. Our local community providers will continue to serve

those patients even if their commercial volume is negatively impacted by MGB. However, these same providers may be financially forced to close much needed medical services, resulting in reduced safetynet care for our communities' most vulnerable patients, while the more privileged migrate to MGB. In closing, I would state that the proposed MGB expansion into Woburn would exacerbate healthcare inequities and further the injustices that many are trying to correct. As we become increasingly aware of dwindling resources and sky-rocketing costs, the answers lay in healthcare cost-containment, partnerships, and the spirit of equitable collaboration where all sizes and types of healthcare organizations work together to benefit their communities. Therefore, I respectfully ask the Massachusetts Department of Public Health to closely look at this request, do a full data analysis and impact study, and hold additional public hearings. I would sincerely ask the MDPH to opportunities to *enhance* the resources of existing *local / regional* healthcare services rather than duplicate them with costlier ones that exacerbate current inequities.
