I believe it's valuable to remember that in 2016, the proposed merger between Partners Health Care and Hallmark Health Systems (MWH, LMH) was blocked by the Attorney General and her statement at the time was that:

"One of the greatest challenges for our Commonwealth is controlling health costs while promoting quality and access." In her comments she also stated that she had blocked the merger with that goal in mind.

There are already high quality, low cost options for medical care in the service area of the proposed Woburn ASC site. MWHC has an Ambulatory Surgical Center in Medford at the former LMH campus less than 10 minutes away from the Woburn location. And they also have private and employed PCP's in greater Woburn communities who refer patients into the highly integrated Wellforce system which uses two truly low cost community hospitals (Melrose Wakefield and Lowell General) as well as Tufts Medical Center (the lowest cost tertiary care center in Boston).

We've done some data analysis in our PHO risk contracts looking at several common ASC level outpatient procedures. Our data shows that when an outpatient (ASC-type) procedure is done at MGH, the cost is on average 50-60% higher than a similar service done at MWH. Because Partners is well known to use its market clout in its price negotiating

with payors, we anticipate this type of pricing discrepancy will carry itself into the MGB vs. our community hospital ASC.

If our goal in Massachusetts is to allow the *truly* low cost systems to be viable, then we can't continue to support the expansion of the highest cost provider into their primary and secondary service areas.

Our Attorney General warned in 2016 that we need to take measures to ensure viable, high quality, low cost medical care for Massachusetts residents. An MGB ASC in Woburn may not appear to be as big a threat to cost as hospital mergers, but ultimately, it will bring about the same demise of the low cost provider with the "death by a thousand cuts". Please don't allow this to happen. Thank you for this opportunity to share my thoughts.

Dear Madams and Sirs:

I am a resident of Winchester who works at Winchester Hospital and Melrose Wakefield Hospital, as well at Digestive Health Associates in Stoneham. At our center, we perform endoscopies and colonoscopies that the Massachusetts insurance industry and the Commonwealth list on their websites comparing costs of common procedures. A colonoscopy at our center is estimated to cost the insurer or patient approximately \$1,000 after all fees are paid. The same procedure at a Mass General Brigham outpatient facility is estimated to cost more than \$3,000. We maintain that the quality is the same or better at our facility (with the majority of our medical staff having been listed as "Best of Boston"), but the profit margin is a fraction of that reaped by Mass General Brigham facilities

This outrageous difference in cost to the healthcare system is due to the market share and bargaining power of the MGH-Brigham system. Establishing another outpatient center for Mass General Brigham in Woburn would have the impact of encouraging patients in our community to choose the more expensive (for their insurers) option while simultaneously further increasing the Mass General Brigham market share and bargaining power.

This would not only drive up healthcare costs substantially, but would potentially lead to closure of our community hospitals as well as our endoscopy center.

I have great respect for the tertiary care capabilities of institutions such as Mass General and Brigham and Women's Hospitals, and I often refer to them when I have a patient with an exceptional condition that requires highly specialized care. However, this proposed expansion into routine community-based practice is an overreach that does not improve local care, but merely consolidates it in a manner intended to increase these large institutions' control over the healthcare of the entire region. Allowing this expansion would drive out local resources, drive up costs, and could force closure of both Melrose Wakefield and Winchester Hospitals.

Unless our local hospitals are shut down by unfair competition from Mass General Brigham, members of our communities will continue to have excellent access to outpatient facilities, physicians, nurses and allied staff. There is no "need" that would be fulfilled by creating the proposed facility.

Please look closely at who would be the beneficiary and who would be harmed, and put a stop to this blatant attempt to expand market share through unfair competition in an environment where there is no need.
